Hiring foreign-university graduates is an integral part of the talent strategy for a large percentage of companies. Foreign university graduates are found to score favourably on several parameters. They

are found to be better prepared for a job, require lesser training, and have stronger communication and critical thinking skills. All these factors contribute to the attractiveness of foreign university graduates.

Graduates from UK universities are preferred and are favourably placed at the top behind the US. Germany and Australia rank a distant third and fourth respectively. This is not a surprise given the UK's long-standing focus on quality. Four of the world's Top 6 universities are from UK. These were the key findings from the India Employability Survey Report 2014 which spoke to 200 HR directors/staffing directors of Indian organisations that hire foreign graduates.

With this initiative, the British Council continues to work towards promoting the UK as a study destination. In an endeavour to attract talent from India, the British Council recently announced the GREAT Britain Scholarships - India 2015 in partnership with 57 UK universities offering 401 part scholarship awards worth 1.51 million pounds (approx. 151 million rupees) to Indian students in varied subject areas ranging from Engineering. 


