English-Language Course in the UK for Colombian Students (Young Learners)

Call for Proposals

UK-based, 2 week General English-language course for a group of 10

young Colombian students (12-17 years old | all levels)

The British Council Teaching Centre in Bogotá, Colombia is looking to offer their registered

students a 2 week English Language course by an accredited British Council provider in the

UK, to deliver 15 hours of English language teaching per week for a group of young students

from Colombia. The course should be a combination of classes in the morning, a range of

sporting and cultural activities in the afternoons, with cultural excursions on the weekends,

which we would like to be Harry Potter themed, such as Harry Potter locations walking

tours and/or Harry Potter studios tour. Classes to be taken by the students should be

integrated with students from other countries to promote intercultural relations and the use of

the English Language, as long as it meets the students English language requirements.

Duration: 2 weeks

Travel dates: 15-30 June, 2019

Course Dates: 17-28 June, 2019

Group Description:

A group of 10 young Colombian students, with all levels of English wishing to

improve their general English skills (age range: 12-17).

1 accompanying adult (however, we will still need a representative of the

institution to be assigned to the group).

Accommodation:

The British Council Colombia would like costing with regards to accommodation in

residence. The institution will arrange accommodation according to the details below:

1. For 10 junior students in a residence. Local staff will be responsible for overnight

supervision of students.

2. Meals: breakfast, lunch, dinner & evening snacks for all students and group

leader.

Cultural Activities:

These are additional components of the course which will enable students to learn more about the country, its people and culture. Activities should be planned head of time and have a learning objective, hopefully linked to what students are seeing in the classroom. A detail program of activities and Institution Activity Leaders assigned will be requested if selected.

Since the UK is an important location of the Harry Potter's movie making, we would like to offer this course as a themed summer trip. As a result, the proposed cultural activities must be related to Harry Potter.

Proposal Terms of Reference:

- Justification;
- General and specific objectives of course;
- Teaching methodology and course content;
- Additional components and/or features to the programme (e.g. use of new technologies to support the learning of English; range of sporting/cultural activities available);
- Assessment System (including final student report);
- Materials to be used;
- Initial and final placement test;
- Certification;
- Proposed breakdown of costs/budget;
- Child Protection Policies in place within the institution
- Any other additional activities/services as a plus from the language school;
- Desirable: Variation of activities in different locations on or off-campus;
- Contact details of dedicated person assigned to British Council group.

The breakdown of costs/ budget should include:

- Tuition (course fees);
- Airport transfers from Heathrow Airport;
- Local transport if necessary;
- Accommodation;
- Meals (Breakfast, hot lunch, dinner & evening snacks);
- Placement test on arrival and departure using the same testing system;
- Course materials for each student;

- Final report of students' progress and certificates;
- Costs of cultural/other activities (entrance fees/hire of equipment etc.), excursions;
- International health and travel insurance.

ACTION REQUIRED

Proposals will be assessed according to compliance with the terms of reference above and breakdown of costs/budget. Only institutions shortlisted for consideration will be contacted for follow-up. Once a winning bid is confirmed we will announce the results through Newswire.

British Council Child Protection Policy

The British Council creates international opportunities for the people of the UK and other countries and builds trust between them worldwide. We believe child protection requires everyone to take responsibility. We recognize that the care and welfare of children is paramount and that all children have the right to protection from all types of harm. The British Council recognizes that we have a fundamental duty of care towards all children we engage with, including a duty to protect them from abuse. We achieve this through compliance with UK child protection laws and relevant laws in each of the countries we operate in, as well as by adherence to the United Nations Convention on the Rights of the Child (UNCRC) 1989.

A child is defined in the British Council as anyone who has not reached their 18th birthday (UNCRC 1989) irrespective of the age of majority in the country where a child is, or their home country. This policy is mandatory for all British Council staff worldwide. This includes anyone who works for the British Council, either in a paid or unpaid, full or part time capacity. This includes directly employed staff, trustees, contractors, agency staff, consultants, volunteers, interns and anyone working on behalf of the British Council.

The British Council is committed to:

- Valuing, respecting and listening to children
- ensuring all necessary checks are made when recruiting staff
- maintaining strong child protection systems and procedures for staff
- training our staff and providing a common understanding of child protection issues to inform planning and practice
- sharing information about child protection and good practice with children and parents/careers
- sharing information about concerns with agencies who need to know, and involving parents and children appropriately
- providing effective management for staff through clear processes, supervision, and support.
- We will provide adequate and appropriate resources to implement this policy and will ensure it is communicated and understood. The British Council will review this global policy statement annually to reflect new legal and regulatory developments and ensure good practice.
