





Why are the Americas important to the UK?

- c. £0.5 billion in tuition fee income alone
- 30% growth in student numbers since 2002
- Broad range of opportunity given the diversity of the markets
- US (5th) and Canada (16th) are top 20 sending countries with substantial growth potential
- Untapped potential in Latin America

Why now?

- USA, BRA, CAN, and MEX
- US-UK bilateral education
- Latin America has a GDP greater than India and Russia combined
- LatAm middle class is bigger than China's and India's together
- US and Canada are two of the UK's largest non-EU import-export partners in the world

Why now?

- Increased UK presence in the region through the FCO from Calgary to Asuncion.
- More support for UK Higher Education through enlarged British Council presences in the US, Brazil and Mexico. New education teams in Canada (2012) and Colombia (2013). Expanding the service throughout the region.
- Over 40 ministerial visits from the UK to the region.







The Caribbean

 Presence of several offshore North American and British Universities (over 100) offering a range of Programmes - predominantly in the larger countries with about 14 offshore medical schools.

Some examples:

- University of New Orleans Master of Business Administration (Jamaica)
- University of South Florida Masters in Early Childhood Education, with Shortwood Teachers College, Jamaica
- Spartan School of Medical Sciences (St Lucia)
- University of London Law (Jamaica)
- City and Guilds of London (Jamaica and Trinidad and Tobago)
- George Washington University (USA) (Jamaica)
- Ross University of Veterinary Science St Kitts

The Caribbean

- Decreasing state funding with attendant increase in tuition.
- One dominant 64 year old regional University with four Campuses serving 16 countries with approximately 45,000 students
- University of the West Indies Jamaica (Mona Campus), Barbados (Cave Hill Campus), Trinidad and Tobago (St Augustine Campus), Open Campus (serving all the OECS countries)
- No common Caribbean strategy for international education individual institutions drive international education to suit their own imperatives.

- An emerging market for Higher Education
- 47 million people
- Growing middle class
- Average age is 28.3 years old
- Increasingly stable security environment
- 2011: GDP growth 6%
- Expenditure on Education 3.12% GDP
- CIVETS member
- Major cities: Bogota, Medellin and Cali

- Nov 2011: MOU signed during Santos visit
- May 2012: Networking mission 15 UK + 25 Colombian universities with ICETEX
- Spring 2013: David Willetts visit





Drivers and opportunities

Opportunities in the Caribbean for UKHEIs

- There is no commonly agreed Caribbean strategy for Higher Education and internationalization.
- There is a rise in off-shore University education.
- Significant opportunities for distance education programmes with recognized UK universities
- Under the GATT, education is treated as a product to be traded with its own sets of rules. The barriers to trade have been removed for signatory countries.
- The educational system in the Caribbean evolved from Britain





Our vision for Canada: become the 21st century leader in international education in order to attract top talent and prepare our citizens for the global marketplace, thereby providing key building blocks for our future prosperity.




Long-Term International Students in Canada (Seven percent annual growth scenario)

- Double international student enrolment by 2022.
- Contribute up to \$16 billion to Canada's economy.
- Encourage top talent to immigrate.

- Increasing research capacity is the major government priority
- Colombia looks to the UK for expertise in designing long-term policy frameworks on Science and Innovation.
- Increasing commercial output of science
- Developing commercial partnerships particularly in biotech, nanotech and health.
- \$5bn allocated to support this work
- COLFUTURO and ICETEX funding programmes

Priority is increasing Colombia's research capacity and quality:

- Mobility of staff: ICETEX faculty exchange programme with a focus on areas aligned to Science, Innovation, Techonology etc.
- Short term research assistantships

Government supported initiative increasing the number of international students (e.g. British!) learning Spanish.

What does competition look like?


The University of the West Indies

St Georges University (particularly for Medical training)

The USA brand:

US off-shore universities right across the Caribbean (offering employment in the US for one year after completion) as well as opportunity to study in the USA under 4-year programmes with significant financial aid.

- Stronger positioning of the UK offer needed, e.g. EducationUK brand
- English language barriers
- Visa challenges requiring additional support
- Financial and corruption concerns
