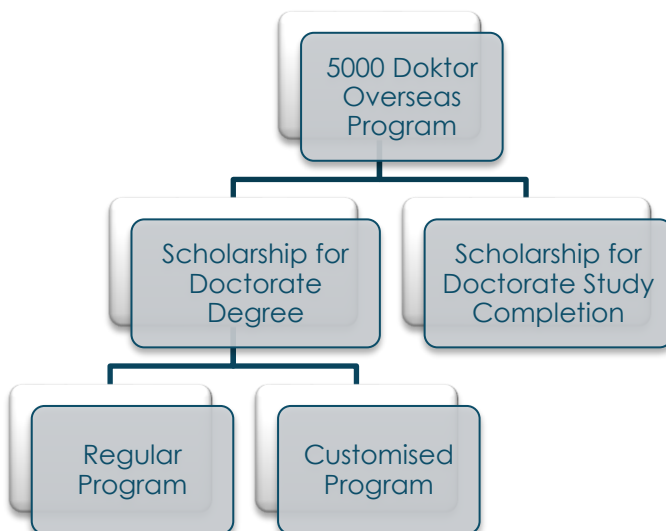

ABOUT 5000 DOKTOR

5000 Doktor Program is a flagship program, officially launched by President Joko Widodo in December 2014, in the Directorate General of Islamic Education, Ministry of Religious Affairs, The Republic of Indonesia.

This program is intended to improve the quality of lecturers and academic staffs within the Islamic Higher Education institutions by offering scholarships for in-country and overseas doctorate programs.

OVERSEAS DOCTORATE SCHOLARSHIP

This scholarship is an aid provided by The Ministry of Religious Affairs, Republic of Indonesia for educators (lecturers) and academic staff within institutions under the management of Islamic Higher Education (IHE). The candidates will pursue their doctorate study at reputable universities overseas. Through this scheme, it is expected that Islamic higher education institutions have more qualified human resources.

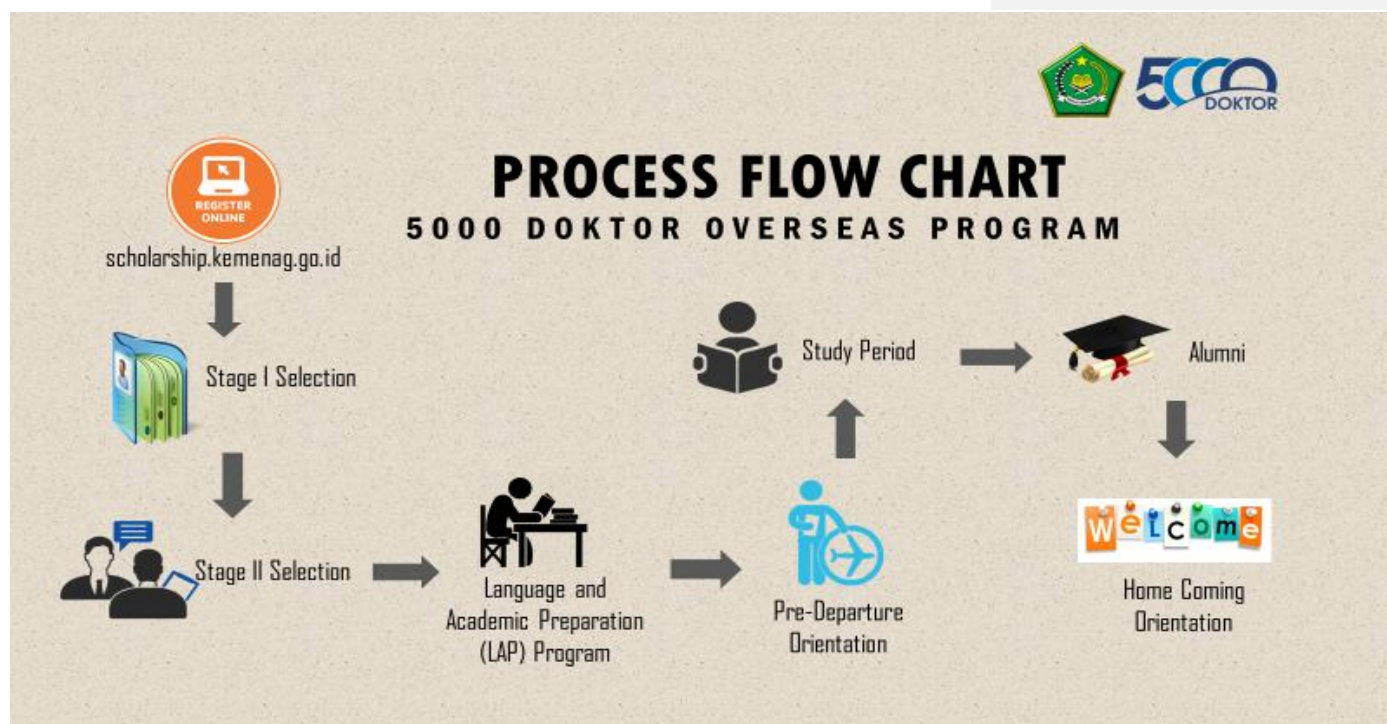
GENERAL ELIGIBILITY

The eligibility of the program:

1. Civil Servant Lecturers of IHE and lecturers at Islamic Faculty of general higher education institutions
2. Civil servant academic staffs of IHE
3. Civil servant at Echelon I Unit, Ministry of Religious Affairs central office
4. Non-civil servant permanent lecturers of IHE
5. Non-civil servant academic staffs of IHE
6. Master degree graduates of Islamic studies.

General Requirements

- a) Have a Master Degree (S2) in study programs accredited by the National Accreditation Agency for Higher Education or have equivalent status (for overseas universities);
- b) Choose areas of study which are requisite to the program development in their institutions;
- c) Willing to sign a scholarship contract;
- d) No older than 47 years of age by the date of application;
- e) Holder of a Lecturer National Identification Number (NIDN), for lecturer applicants;
- f) Register at scholarship.kemenag.go.id



SPECIFIC REQUIREMENTS

Applicants **MUST** submit:

- a. Letter of Request to follow the selection of 5000 Doktor Scholarship Program. The letter is addressed to the Director General of Islamic Education, cq. The Director of Islamic Higher Education. (*template provided*);
- b. Cover Letter from Rector/Head of Higher Education/Head of the institutions where the applicant works (*template provided*);
- c. Curriculum Vitae in English (*template provided*);
- d. Legalised copies of the first and the last Statement Letter (SK) where the applicants work;
- e. Copy of valid Identity Card (KTP);
- f. Legalised copies of Undergraduate (S1) and Postgraduate (S2) Certificate/s and Academic Transcript/s (in the original language and in English). Translations must be done by a **sworn translator**. The minimum GPA (IPK) of the latest education is **3.25** (scale 4.00). All documents are to be attached in one file;
- g. Foreign language certificate/s with a maximum of two (2) years since issued. Please note this extremely important language requirements:
 - 1) Applicants intending to study at English-speaking universities, including universities in France incorporated in INSA (see customized program with **SAST**), are required to submit **English certificate** of TOEFL ITP® minimum 500, or TOEFL IBT® minimum 61, or TOEFL CBT® minimum 173, or TOEIC® minimum 700, or PTE® (Pearson Test of English) minimum 38, or IELTS™ minimum 5.0.
 - 2) Applicants intending to study at Arabic-speaking universities, are required to submit TOAFL Arabic certificate with a minimum score of 450 or its equivalent **AND** English certificate of TOEFL ITP® minimum 450, or TOEFL IBT® minimum 52, or TOEFL CBT® minimum 155, or TOEIC® minimum 625, or PTE® (Pearson Test of English) minimum 34, or IELTS™ minimum 4.5.
 - 3) Applicants intending to study at French-speaking universities are required to submit DELF B1 certificate **AND** English certificate of TOEFL ITP® minimum 450, or TOEFL IBT® minimum 52, or TOEFL CBT® minimum 155, or TOEIC® minimum 625, or PTE® (Pearson Test of English) minimum 34, or IELTS™ minimum 4.5.
 - 4) Applicants intending to study at other foreign language-speaking universities must submit language certificate in accordance with the designated university language medium of instruction **AND** English certificate of TOEFL ITP® minimum 450, or TOEFL IBT® minimum 52, or TOEFL CBT® minimum 155, or TOEIC® minimum 625, or PTE® (Pearson Test of English) minimum 34, or IELTS™ minimum 4.5.
 - 5) The English certificates **must be** issued by either ETS (www.ets.org) or IELTS (www.ielts.org) or TOEIC (<https://www.ets.org/toEIC>) or PTE (<https://pearsonpte.com/>). The committee **only receives** English certificates issued by the above mentioned institutions.
- h. Statuary Declaration signed on the stamp stating that the applicants are not currently receiving scholarship from the Ministry of Religious Affairs or other institutions (*template provided*);
- i. Statement of Willingness to Return to Duty and serve the institution where the applicants work for at least twice as long as study period (n) and a year (2n + 1), commencing after graduation (*template provided*);
- j. Letter of document validity and authenticity (*template provided*);
- k. Dissertation research proposal (maximum 5 pages) in English or other languages which serve as the language of instruction at the designated university (*template provided*);
- l. Proof of correspondence with the designated university and/or potential supervisor;
- m. Letter of Acceptance (LoA) from designated university. (**optional**)

SCHOLARSHIP COMPONENTS

The scholarship components cover the following items:

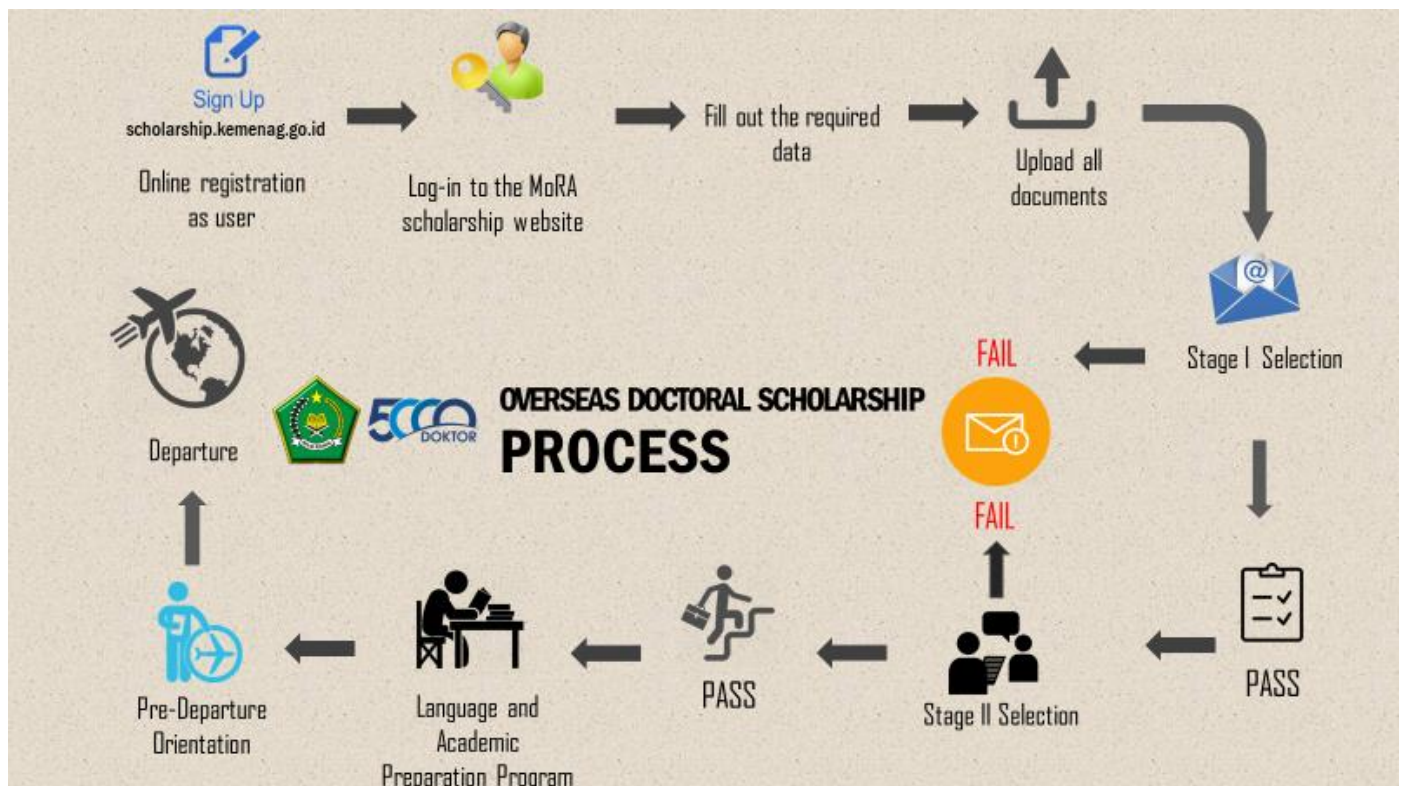

1. Language and Academic Preparation (LAP) Course fees in Indonesia;
 2. Living cost during LAP Course;
 3. IELTS® or TOEFL® or other languages tests required by the targeted universities (once);
 4. University admission fee (if any);
 5. Tuition fee;
 6. Living cost during study (maximum four years);
 7. Settlement allowance;
 8. Health insurance;
 9. Book allowance for year 1-3;
 10. Return ticket airfare (economy class);
 11. Visa fee;
 12. Family allowance (as of the second year of study for a maximum of two years);
 13. Research allowance (once);
 14. International conference fees (as a speaker).

- ✓ Terms and conditions regarding the amount of living cost, settlement and book allowance are regulated in the Decree of the Director General of Islamic Education regarding the Provisions of Costs and Scholarships Standard for Overseas Study.
 - ✓ Research allowance and international conference fees are subject to satisfactory proposal and are settled based on the review result.

OVERSEAS DOCTORATE SCHOLARSHIP

SELECTION AND POST-SELECTION PROCESS

In general, this scholarship program has two stages of selection: Stage I is the administration selection where all documents will be reviewed in terms of their eligibility and authenticity. Applicants who meet the satisfying result will proceed to Stage II. In this stage, the applicants will follow some tests consisting of essay writing, interview, language tests, Academic Potential Test (TPA), and psychotest. Successful awardees will be given the opportunity to join Language and Academic Preparation (LAP) Program. Such programs aims to improve foreign language proficiency in accordance with the language of the instruction at the targeted university, finding potential supervisors, obtaining a Letter of Acceptance (LoA) from the university, and having adequate academic and non-academic skills to study in a foreign country, such as proposal writing, scientific articles, critical review, research methodology, academic networks and communication, and cross cultural skills. At the end of the program, awardees are expected to obtain Unconditional LoA and are ready to study overseas. The process is depicted in the following:



OVERSEAS DOCTORATE SCHOLARSHIP

As has been mentioned previously in the guidelines, the scholarship for doctorate degree consists of two (2) schemes: The Regular and The Customised Program

REGULAR PROGRAM

The Regular Program of Overseas Doctorate Scholarship gives wide opportunities to prospective applicants to pursue their doctoral study at reputable universities overseas.

The Regular Program allows wide opportunity for awardees to choose their university destinations. When doing so, they should consider the following:

1. Ensure that the university has supervisors who are experts in the field of study the awardees are willing to take;
2. Ensure that the university has a good reputation. Some ways to confirm its reputation are outlined below:
 - a. Times Higher Education (THE) or QS University rankings.
 - b. A list of foreign universities approved by the Higher Education (DIKTI), the Ministry of Research, Technology and Higher Education (<http://ijazahln.ristekdikti.go.id/ijazahln/>).
 - c. A list of foreign universities approved by Directorate of Islamic Higher Education (PTKI), the Ministry of Religious Affairs (contact subdit_akademik@kemenag.go.id, or <http://diktis.kemenag.go.id/penyetaraanijazah/>
3. Universities which are not included in Point 2 may still be considered if the followings are evident:
 - a. A letter of recommendation by an alumni in the intended study program, or
 - b. The availability of expert professors in the field of study the awardess are willing to take.

OVERSEAS DOCTORATE SCHOLARSHIP

CUSTOMISED PROGRAM

The Customised Program of Overseas Doctorate Scholarship is one of the accelerated efforts in sending educators (lecturers) and academic staffs to continue their doctoral studies at overseas universities that have cooperation with the Ministry of Religious Affairs. Generally, this program provides more advantages compared to the regular program, such as:

1. The selection process is carried out jointly by professors from university partners and the Ministry of Religious Affairs. As a result, awardees will have greater chances to be accepted at the targeted university;
2. The awardees are provided with additional programs to improve their English and academic skills held in university partners for 10 weeks (for special pathways leading to PhD);
3. Proposal writing assistance*;
4. Assistance in finding potential supervisor;
5. Assistance and consultation in terms of choosing appropriate study program;
6. Intensive monitoring and consultation in obtaining Unconditional Letter of Acceptance (LoA);
7. Monitoring and consultation during study.

*Applicable only in certain universities

Special Pathways Leading to Ph.D (SPL-Ph.D)

The 5000 Doktor scholarship program has actively established partnership with various overseas universities. The partnership aims to assist the awardees' transition in pursuing their doctoral study. **The University of Canberra, Western Sydney University and Central Queensland University**, for examples, are university partners for Special Pathways Leading to PhD. (SPL-PhD). Awardees can choose one of the above mentioned universities as their designated university. Similar to the regular program, the special pathways leading to Ph.D. program with some additional assistance. The awardees choosing this scheme are entitled to the following:

1. Assistance in finding potential supervisors in accordance with the research proposal;
2. Can be accepted at one of the three universities with a minimum of IELTS 6.0 (with no band less than 6). Awardees are required to join an additional program to strengthen their English and academic skills for 10 weeks at the designated university.
3. Provide consulting assistance to chosen field of study and academic administrative proceedings;
4. Consultation service regarding fields of study and academic administration assistance.

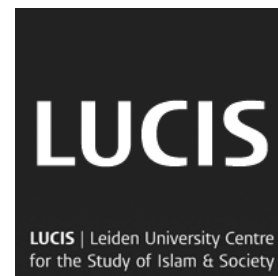

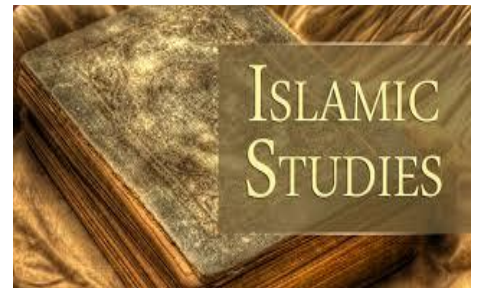
