Professional development online courses for 30 Russian early-career researchers

Background

The British Council run programme "UK-Russia University Alliance" aims to support early career researchers' mobility and internationalisation of Higher Education and research.

Objective

One of the intended outcomes of the 'UK-Russia University Alliance' programme is a strengthened community of Russian early career researchers who are open to UK ideas and positive towards the UK, who see the UK as a source of science excellence and an attractive longer term career partner for future joint research initiatives.

To achieve this, we are opening a call for proposals to offer early career researchers from Russia, online professional development courses focused on improving their academic writing and presentation skills, enabling them to:

- Publish in international journals,
- Write convincing joint funding bids with their UK counterparts and,
- Deliver quality public presentations in English.

Services Required

Summary description of service	 A short online course, delivered in English focused on improving academic writing and presentation skills 10 hours (minimum) course of group contact time. This could be delivered over 2 - 4 weeks or upon proposal suggestion. Such as two sessions to set out course, time to complete work and two sessions to review and complete 1 x 1-hour one-to-one review tutorial start of course 1 x 1-hour one-to one post course follow-up meeting Certified on completion
Approach	 Professional development course should be provided online, with dedicated contact time from course tutors. Provision must be engaging and interactive. Consideration should be given to including material regarding relevant funding opportunities for UK-Russia collaboration Presenting to an audience in real-time with peer-to-peer feedback to be included. Online format with face-to-face Access to wider peer group of early career researchers and identifying involvement would be beneficial and bidders should identify if this is an offering Delivery Self-study assignments to be given and pre-reading assigned

	 Group sizes should be small of around 6-8 participants. Proposals of large groups will be considered if justification and reasoning of learners benefits are identified Course participants should leave the course with a clear understanding of how to make continuous improvements on their skill sets for the future.
	 Learning outcomes to be measured amongst all early career researchers, with feedback mechanisms throughout the course Evaluation and recommendation report will be required Delivery platform should be acceptable in Russia. E.g. Microsoft Teams or Zoom.
