What is the Consultant Management System

Answer is simple its ADB's online platform for consultants

The Consultant Management System or CMS (<http://cms.adb.org/>) is an online system where ADB does the following:

- ✓ advertise consulting services recruitment notices (CSRNs)
- ✓ recruit consultants
- ✓ manage contracts and framework agreements
- ✓ process consultants' performance evaluation


Using the CMS, consultants can do the following:

- register in ADB's consultant database
- create and update their profile
- search opportunities
- prepare and submit expressions of interest
- respond to non-committal inquiries (NCIs) or request for proposals (RFP)
- prepare and submit proposals
- respond to contract offers
- submit timesheets and deliverables
- submit claims and advance request
- provide feedback at the end of their consulting assignment

Access to the system is gained by typing a registered email address and password.



To apply for any consultancy opportunity at ADB, you must have a CMS account. When you go to the main page of <http://cms.adb.org/> you would be prompted for registering as a new user. You would find these options to choose from. Please go through the criteria mentioned in this category and see that you meet them.

Responding to Requests for Proposals and Submitting Proposals

How to submit an Expression of Interest (EOI) for a consulting assignment?

- Refer to specific instructions in the specific Consulting Services Recruitment Notice.
- If the notice requires you to answer additional questions relevant to the assignment, you must comply with this requirement. If not, your EOI will be immediately disqualified.
- For consulting service contracts administered by ADB (technical assistance and staff consultancy assignments), ADB's [Consultant Management System \(CMS\)](#) is used for submitting all EOIs. You must have completed your CMS registration in order to submit an EOI.
- For consulting service contracts financed under ADB loans administered by executing agencies (EA) of the borrower, EOIs shall be submitted as directed in the Consulting Services Recruitment Notice. While the electronic submission of EOIs is a default option, some EAs may request submission of EOIs through other means (e.g. paper copy accompanied with support documentation).
