Introduction

Thank you for your participation at the Education UK exhibition in Hong Kong in August. This purpose of this report is to provide you with a summary of the event findings, including visitors survey, exhibitors survey and other findings. In addition to some useful pointers on the Hong Kong market such as subject interest, we trust that this report will enable you to report Rol and assist with decision making for 2014.

We are delighted to announce that overall visitor numbers were once again up vs. last year. Saturday in particular saw an increase on 600 students over 2012, and Sunday also saw a smaller increase. Responses from the visitor survey confirm some recent trends, namely that subject area interest is diversifying away from business to other subject areas.

Some institutions reported that students on the Sunday were enquiring about next year. While we trust that this is useful in maintaining profile and capturing students early in the decision making process, we also acknowledge that the primary objective for most institutions is immediate enrolment during clearing. This with in mind we are closely evaluating the ideal dates for next year, in order to capture as many students as possible following the release A-level results or other key dates. We would greatly appreciate your input as per section 4 below.

KITEC once again proved an attractive venue for students, with no evidence that the move from HKCEC in Wanchai two years ago has any effect on visitor numbers. While KITEC may have its limitations for exhibitors, such as difficulty in finding taxis, KITEC is in the heart of population areas and does not appear to detract from the event. HKCEC is unavailable for at least the next three years due to Hong Kong Trade Development Council's Food Expo, which attracts in excess of 400,000 visitors.

At British Council we highly appreciate your support, and hope that we can continue to provide valuable marketing services in terms of both our exhibitions and also our range of other targeted activities during the year.

2. Recommendations for institutions

- It would be useful to have at least one Cantonese speaker or HK student alumnus at the booth, in order to answer enquiries from parents or students who might not be able to communicate fluently in English as well as provide more 'unofficial' information about the institution which prospective students might ask for.
- Decision making in Hong Kong is based on practical considerations such as exchange and/or internship opportunities and, providing career support upon graduation. These value add selling points are very important in this market.
- There are some seminar topics the visitors are interested in attending, institutions may consider to take up these seminar sessions in our future events:
 - Subject based seminar
 - Introduction of UK postgraduate courses
 - How to choose school/college in the UK
 - How to adapt to the UK culture and accommodation arrangement
 - Alumni sharing session
 - Budget/costing to study in the UK and financial aid for underprivileged students
 - Articulation tot HKU/CUHK medicine after achieving a medical degree in UK

3. British Council response to institution concerns

Below is a summary of areas commented on by institutions, and our response in terms of follow-up actions. Suggestions and comments received from institutions are listed in full in Appendix 4:

Venue

- Many institutions commented that KITEC is not as convenient as HKCEC in Wanchai
 and it was suggested that the central location at Hong Kong Island would have been
 better. Unfortunately, HKCEC cannot secure our booking (even in 2016 summer)
 before they can accommodate all the concurrent events. The possibility of having our
 August exhibition at HKCEC is not great as one of the largest exhibitions in Hong
 Kong Hong Kong Food Expo is normally held in Mid-August, which is at the Clearing
 weekend, and attracts over 400,000 visitors.
- In fact, the number of visitor did not affected by the location as KITEC is near to the residential area in Hong Kong. Kowloon accounts for 30% of the total population in

Hong Kong, while Hong Kong Island just account for 18% of the total¹. We believe KITEC is another suitable venue for our exhibition with limited options in Hong Kong.

Some exhibitors commented that the catering was not satisfactory. As KITEC is the
sole management of the catering service in the exhibition area and has the exclusive
right to serve food and drink in the venue, we cannot order outside catering for our
exhibition. In spite of this, we will carefully select the menu next time and ensure there
will be sufficient supply of food and drinks throughout the event.

Timing of the event

• There were some exhibitors suggesting to hold the exhibition earlier - The event should take place on Friday and Saturday, the day after A-Level results are released. In order to maximize the interest for all UK institutions, we are now doing a survey and find out which day will be the best time to do our summer exhibition next year. For your information, the HKDSE, JUPAS and GCE A-level result release dates in 2014 are as follows –

HKDSE result - 14 July

JUPAS result - 8 August

GCE a-level result – 14 August (UK time)

Participation fee

- Some institutions commented that the participation fee in Hong Kong was high. It is mainly due to a) high exhibition venue rental cost and b) expensive event promotion in Hong Kong. Despite of this, the exhibition fee did not increase from last year
- In total, we spent around GBP75,000 on advertising and promotion, which is more than 56% of the total exhibition budget. This spend creates high awareness of the exhibition and UK education in general, with the result stimulating the market and driving attendance.








4. Key Visitors survey insights

- As per previous years parents are not confident in Hong Kong Diploma of Secondary Education, and this year this phenomenon remains the case. The main reason is public uncertainty and nervousness about the education reforms implemented in 2009 and not sure if HKDSE would be internationally recognised for university access.
- Although all students entering Secondary Four can now complete senior secondary
 education in Hong Kong, the survey indicated that there are stronger interests from Hong
 Kong students looking to move to UK earlier to study GCSE and GCE A-level, in order to
 skip the HKDSE exams in Hong Kong. So, institutions should able to provide advice on
 pathways available to them at different stages of education.




What programme of study are you interested in?



Students are looking increasingly for specialist subject information and their areas of interest are diversifying from the traditional business management subjects. Subjects like Law, Social Science and Health and Medicine are now becoming more popular compared with last year. It should be acknowledged that schools in Hong Kong are becoming more sophisticated in the higher education counselling that they provide to students, as reflected in the higher quality visitors and the in-depth enquiries that they make. Exhibitors should therefore be prepared to provide in-depth information about courses and subjects offered by their institutions as well as general information about admissions.

5. Prospects for Hong Kong Student Recruitment

Since the launch of the new secondary curriculum in September 2009, the reforms were believed to still play a significant role in motivating parents and students into considering alternatives. The articulation of the HKDSE to UK higher education and implications of Hong Kong's new education system for studying in the UK will clearly continue to be focal points for this market for the next few years.

Hong Kong is a robust market for student recruitment, with a continuing lack of publicly funded higher education provision. This lack of provision will not change any time soon, meaning that Hong Kong will for the time being remains a relatively safe bet.

While this overall market status remains unchanged, under the surface the last couple of years have seen some significant changes. While entry requirements and pathways for HKDSE graduates have now been set, some of the resulting implications are now being more clearly understood. Foremost among these is a diversification of subject interest. This was initially picked up on last year, and appears to have accelerated this year. While business is still the number one subject area of choice, the gap appears to have significantly narrowed to medicine and law, with other areas in social sciences and humanities showing an increase in enquiries. Engineering also appears to have reversed a recent decline. This provides an opportunity for institutions to spread its international student population across faculties, and as a mature market Hong Kong has a role to play in this regard.

Besides, institutions should also be aware that there were 68% of the students (year 2013) sat for 4 core subjects + 2 elective subjects at their DSE exams, institutions should consider to adjust their entry requirement accordingly.

While the market remains buoyant, Hong Kong is a sophisticated market where competition among institutions is fierce. In order to differentiate your institution it is therefore becoming increasingly crucial to clearly articulate faculty strengths and sell the benefits of particular courses.

As with many markets, Hong Kong parents and students are also showing increasing pragmatism. Subject choices are closely linked to perceived career opportunities (this is one driver behind the subject diversification), and universities who are able to demonstrate industry links and speak in these terms will have an advantage. Career support upon graduation and meaningful alumni activities are other advantages that may provide an advantage.

In consideration of these factors, at British Council we are offering a wider range of marketing opportunities to supplement the exhibition. These include subject specific information seminars, value add seminars such as writing a personal statement, and a mooted careers fair for graduates of UK universities. We look forward to discussing these opportunities with you as valued institution partners in due course.
