Overview of the British Council

We build connections, understanding and trust between people in the UK and other countries through arts and culture, education, and the English language. We work in two ways – directly with individuals to transform their lives, and with governments and partners to make a bigger difference for the longer term, creating benefit for millions of people all over the world.

We help young people to gain the skills, confidence, and connections they are looking for to realise their potential and to participate in strong and inclusive communities. We support them to learn English, to get a high-quality education and to gain internationally recognised qualifications. Our work in arts and culture stimulates creative expression and exchange and nurtures creative enterprise.

We connect the best of the UK with the world and the best of the world with the UK. These connections lead to an understanding of each other's strengths and of the challenges and values that we share. This builds trust between people in the UK and other nations which endures even when official relations may be strained.

We work on the ground in more than 100 countries. In 2019-20 we connected with 80 million people directly and with 791 million people overall, including online and through our broadcasts and publications.

We are funded by a grant-in-aid from the UK government and with significant additional income from partnership agreements, contracts, teaching and exams.

Founded in 1934, we are a UK charity governed by Royal Charter and a UK public body.

English in Education Systems

The British Council's work in English for Education Systems (EES) aims for transformational change in English language policy and practice. We believe that better teaching and learning of English increases academic and career opportunities and enables people to participate actively in a global society. Our research and innovation with UK and overseas partners provide evidence of 'what works' in English language teaching and learning and contribute to the development of English language teaching and learning worldwide. We support language teaching and learning in a multilingual world, helping to ensure inclusive and equitable quality language education in line with UN Sustainable Development Goal 4.

As of 2022, our EES programmatic framework is thematically organised into three key impact areas:

- ELT in Education,
- English and Empowerment
- English Connects (digital)

Underpinning these priorities is our approach harnessing UK expertise in teacher education, education technologies and inclusive pedagogies and research, insight, and innovation. We seek to document and share learning gained from practical experience. Our role in global English means that advancing thought and positioning the UK as leaders in English language education are at the heart of our mission.

Context of the Call for Application:

Yunnan province lies on China's Southwestern border. The capital city is Kunming. Yunnan is home to many of China's ethnic groups and is renowned for its beautiful rolling, green scenery, and wonderful food. However, behind these famed attractions lies one of China's most underdeveloped and hard to access regions. Mountainous terrain and limited access to quality resources has meant that many schools, teachers, and students have not had the same opportunities to provide, or access, quality education as their suburban peers. This is particularly the case within English language teaching where levels of teacher training and language competence have played a significant part in hampering the progress of both teachers and students.

In 2020 - 21, the Chinese government not only achieved its goal of eradicating "absolute poverty", but it also outlined more details of its ambitious educational modernisation plan with key goals to be achieved by 2035. These goals strongly focus on achieving greater education equity and parity across the nation along with the revitalisation of rural economies and improvement in national education systems. Supporting rural areas is an area that the Chinese government have spent billions of dollars on through various programmes since the turn of the century, and as of 2021 had "hired 950,000 university graduates to teach at more than 30,000 rural schools in more than 1,000 counties in 22 central and western provincial-level regions." However, while there is a continued push to support these areas, especially now with the adoption of online learning and digital resources catalysed by the COVID-19 pandemic, the support provided to these teachers, both pre and in-service still requires improvement; and sustainable solutions for development – particularly in areas of English language teaching – remain a priority.

English language can play a significant part in supporting rural revitalisation, and offers new opportunities to students in rural areas, but there remain many barriers to the development of English teachers including lack of access to quality resources; low skill levels and low motivation to develop; low language levels amongst teachers and students, and the fact that language is sometimes seen as less locally relevant than other subjects. This is compounded, in some areas, by additional pressure being placed on public school teachers through the effects of the 2021 Double-Reduction policy regulating provision of compulsory subjects in the private sector (I.e., English), although conversely this may also offer an opportunity for English teaching to be improved in the public sector.

Through working with identified key partners in Yunnan province at pre- and in-service stages, this award seeks to support the capacity-development and empowerment of teachers through building their experience and awareness of accessing Professional Learning Communities (PLCs) that improve their practice and teaching knowledge. The award intends to increase awareness and motivation amongst teachers to not only access external resources, both online www.britishcouncil.org

and offline, but also sustainably work together to share and contribute to their practice and development through peer led contextual communities that can better meet local needs in the longer term. And to do so in a way that supports teachers at all stages of their career in the less-developed areas of Yunnan province.

Call for Application (CFA)

EMaDA: Supporting sustainable English teacher CPD in Yunnan province

1.1 Overview of Funding Opportunity

The British Council China is now inviting grant applications from UK organisations for 3 targeted China-UK partnerships supporting sustainable English teacher Continuous Professional Development (CPD) in Yunnan Province, Southwestern China.

This call for application provides a unique opportunity to contribute to understanding and improving the CPD options of English language teachers in rural and under-developed areas of Yunnan province. The proposed research brings together a comprehensive and potentially inter-connected focus in both pre-and in-service English teacher development that can holistically contribute to sustainable, contextualised practice and collaboration being engrained within future English teacher education for both new and experienced teachers. Establishing key needs and providing referenceable findings and frameworks for PLCs that support English teachers both pre and in-service offers an exciting opportunity to provide important insight for policy makers and decision makers and make a significant difference in both the short and long term.

Brief Overview of Projects

An overview of the awards can be found below, with further details provided by the local partners available in **Appendix 8.** The awards focus on:

<u>Pre-Service:</u> Supporting the creation and design of a core postgraduate course module¹ for English teachers that specifically meets identified needs of English teachers in rural and mountainous areas of Yunnan province, with guidance in creating PLCs embedded within the new module structure to support and encourage sustainable peer led learning opportunities. **Outputs:** Research report; module outline(s) and supporting documentation incl. guidance


<u>In-service</u> (teacher focused): Piloting a cross-regional PLC between participating secondary schools in two counties of Yunnan province, with the goal of understanding challenges and providing specific guidance on the future creation and expansion of such events across the province based on experiences and research.

Outputs: Research report; PLC pilot; referenceable framework for creation and facilitation of online PLCs in the local context

<u>In-service</u> (Expert Teacher focused²): Supporting the development and networking of existing Expert Teachers to facilitate online training and create PLCs that support English teachers in harder to reach areas of Yunnan province.

Outputs: Research report; short, recorded online training session(s) (6 hours approximately); online support manual for Expert teachers – with training session(s) embedded for reference; *optional:* joint publication of a research paper.

The 3 projects represent an opportunity to combine and lay a foundation for developing teacher autonomy and capacity in a sustainable manner. While they can be completed individually, they have been presented together in this call to highlight the opportunity for a more holistic and comprehensive approach, with professional learning communities at its core, that can achieve greater impact provincially and nationally.



These collaborative project awards are offered as individual projects or 2 or 3 projects that can be undertaken together under the guidance of a single UK partner or UK-led consortium led by a principal UK applicant. Some key points of note:

- A single UK partner or UK-led consortium led by a principal UK applicant for all 3 projects is preferred. In such cases project content, outputs and findings can potentially be linked where opportunity for synergy is identified. In order to highlight this a consolidation report, in addition to the project specific outputs noted above will be requested. Extra funding will be awarded for this purpose (See section 3).
- All individual projects are expected to produce professional, disseminable research reports that will be of national significance in the context of Chinese government goals for educational equity and supporting rural education.
- Where practical it is requested that applicants highlight how digital or online resources and methods will be employed to maximise impact or reach of the proposed research and outputs.

This call for application focuses on 3 distinct projects that fall under the English Materials and Development Award (EMaDa) framework as outlined in section 1.2 below.

1.2 Research Award

EMaDA

The China English Materials Development Award (EMaDA) is an award that:

• promotes UK - China collaborative <u>technical research partnerships</u>³ which can support national education priorities and create <u>impact at a provincial or national level</u> within identified areas of ELT in Chinese formal basic education. This is achieved through the implementation of targeted, nationally relevant research <u>and</u> subsequent creation of contextualised materials and/or content that supports and sustains a positive impact in English teacher CPD and the quality of English teaching, learning and assessment.

Within the China Official Development Assistance (ODA) context, the award seeks to identify prominent local partners and areas of need in alignment with China national policies and priorities and then connect these partners with UK expertise. The EMaDA award seeks to generate both insightful and nationally relevant research while also providing related context-led material and/or content creation that can promote sustained and meaningful impact.

1.3 Research Areas

In relation to China's national educational priorities, local China partners, at national and provincial level, have been first identified by the British Council. This means that UK organisations do not have to source further local partnerships for project activities and, instead, are invited to apply to collaborate directly with the selected Chinese partners to meet contextual needs under the relevant grant funded award(s).

Research programmes associated with partner needs will broadly fall under at least one of <u>5</u> <u>key research areas</u> that are in line with national educational priorities. Further detail and contextual information can be found in **Appendix 7.**

- Supporting English teaching in rural areas
- EdTech and digital solutions for English teacher CPD
- Assessment reform and English teacher's assessment literacy
- New curriculum and material development
- Broader English teacher CPD and policy

Note: In line with ODA grant funding requirements all applications <u>must</u> also explicitly include consideration of gender, inclusion and/or girls' education. See *section 11* for more details.

If offered, attendance or non-attendance of such a briefing has no bearing o\ the application shortlisting or selection process. It is only for informational purposes.

2. Eligibility

- The British Council welcomes applications from UK ELT and EdTech organisations or institutions with relevant qualifications, expertise and experience required to meet identified partner requirements.
- We are inviting applications for innovative responses to this open call. Applications for partnerships are open to UK organisations only. This must include at least one partner within the UK Applicants living in the UK at the time of application and for the duration of this project.
- Applicants with in kind or matched support are welcome, and the option for recording this is
 provided in the application form, although this is not essential. Match funding cannot be
 provided through other British Council funded programmes.
- Applications should be jointly submitted and signed by all named collaborators, with one
 principal applicant e.g., a lead UK partner organisation, who will be contracted and
 responsible for leading communications and disseminating the grant to all collaborators.
- Organisations and/or informal collectives/networks are eligible to apply but should have demonstrable experience of managing similar projects and grants.
- Applicants must be able to demonstrate how their involvement will provide clear benefit to China, the Chinese partner, and the proposed project. This should be reflected through proposed project planning (including budget allocation), delivery and dissemination and includes demonstrating how the local partners or their audiences may benefit. Mutuality must be a principal component to our international collaboration.
- We expect applications to embed principles of equality, diversity and inclusion through their core proposal and idea (including, potentially, costs relating to captioning videos or translating content where applicable).
- We are interested in new, original ideas and approaches in response to this brief. Existing
 completed research, projects and programmes will be ineligible. Exceptions apply for
 existing ideas, where applicable, which have reached a pilot or prototyping phase but have
 not been realised publicly or implemented.
- Applicants will be expected to plan, design, and realise their project between March 2022 and March 2023 (EMaDA) Main activities can take place any time during the year, although we anticipate that you will respect the annual academic calendar (and holiday breaks) in China.⁴
- Successful applicants will hold the copyright of any work created (unless otherwise stated⁵) but must grant the British Council, the Chinese partner and the China Ministry of Education, free and unequivocal use of any arising outputs, which may include publication, reference,

promotion of works through our digital channels, supporting other projects or exhibiting works in the future. For the avoidance of doubt, this license will not include use of any work our outputs for commercial purposes.

- Successful applicants will be required to keep in regular communication with the British Council, offering project updates and share their project monitoring and evaluation progress and final reports for review and publication.
- Depending on the nature of the project, UK partners may need to show evidence of relevant indemnity cover and related insurance provisions for research activities. The details and nature of insurance required should be confirmed at the time of application.

3. Total Funding and Project Duration

Funding can be applied for individually or as a collective of 2 or 3 projects.

The funding for each award is divided into the following amounts:

EMaDA: Up to 30,000GBP per individual award

For a UK-led consortium application, where one UK organisation would like to apply for 2 or 3 projects and oversee the completion of these in parallel, including the identification and assimilation of relevant synergies between those projects and a consolidation report they may apply for:

- 2 projects up to 65,000GBP
- All 3 projects up to 100,000GBP

to reflect the additional administration and project management costs that this may bring. Where 2 or 3 projects are undertaken by a single UK partner or UK-led consortium led by a principal UK applicant, an additional consolidation report highlighting connections and synergies between projects is expected. This is an additional output, beyond those listed for individual projects.

The listed EMaDA awards projects will be expected to start in **March 2022 and can run for a maximum of 13 months (until late March 2023).** The funding is for the whole project duration and not per annum. Terms and Conditions of this grant is set out in Appendix 4: Grant Agreement.

4. Eligible Costs

The budget requested in your application should cover only costs that are essential, appropriate, and relevant to the collaboration ensuring value for money. The application should specify any cost share through direct and indirect institutional contributions.

Where multiple project awards are applied for, one budget form can be used but the amounts related to each award should be clearly differentiated.

Please find the List of Eligible and Ineligible Costs in **Appendix 3.** You may contact the British Council if you are in doubt which costs the grants can and cannot cover.

5. How to Apply

Please note that if you choose to apply for more than one project:

- 1. provide a completed application form for each project
- 2. provide a cover letter to highlight why your organisation should be awarded 2 or 3 projects, and how you plan to synergise the results of each to maximise potential impact.

Application Process and Selection

Upon receipt of applications, and after confirming all necessary criteria are met and necessary documents have been received, up to <u>3 individual applications</u>⁶ will be shortlisted for each project and these submissions will be shared with the relevant Chinese partner for further review. Applications that apply for more than one project, or all projects together, will be assessed as a whole and automatically shortlisted if criteria are met.

Upon completion of shortlisting, the British Council will support a *negotiation and confirmation stage* between the Chinese partner and shortlisted UK applicants to confirm any outstanding details before final selection. This is normally completed through email. A final decision will be made on successful applicants primarily by the Chinese partner and based on appended scoring (See **Appendix 6**). Support and clarification will be provided by the British Council during the selection process to ensure assessment and scoring criteria are adhered to.

- Alignment with grant strategic objectives (30 points)
- Principal Applicant and its partner's capacity to deliver on time and within budget (30 points)

8. Payment of the Grant

After the results are announced, the British Council will sign Grant Agreements with the successful principal applicants. Unless stated otherwise, funding from British Council will be administered within 60 days of the signature of the Grant Agreement and all funded applicants must submit a declaration confirming they have received the funds.

The grant recipient institution that signs the agreement will then be responsible for the management of the grant (including financial reporting). The Principal Applicant is responsible to communicate and agree with their identified research team on the project's grant management and disbursement. The final terms will be communicated to successful applicants.

The British Council reserve the rights to recover full payment if the final report and supporting documents are not satisfactory, or the activities have not been delivered as planned.

In cases where the projects have spent less than the funding awarded, the underspend cannot be used for further activity unless agreed in advance by the British Council.

9. Implementation

All funded projects must be implemented in accordance with the submitted application, Grant Agreement, and other formal / written communication by the British Council. Any changes to proposed project activities must be approved by the British Council before going ahead.

10. Digital Platform(s)

13. Project Reporting, Monitoring and Evaluation

13. 1 Quarterly reporting

To ensure grant awards are being used appropriately and to highlight progress of the research project, in addition to the final outputs, the Principal Applicant is responsible for submitting Quarterly progress reports9. Initial quarterly reports shall generally consist of narrative and financial information that tracks progress against milestones / plan. In addition to this, the Principal Applicant will be required to submit a final narrative and financial report within 30 days upon completion of the project. Project report templates can be negotiated and agreed.

Reports will normally be accompanied by a pre-arranged meeting between the British Council, UK partners and China partners¹⁰ (June; September 2022). Provisional dates for reporting and catchup meetings can be confirmed after signing of the grant agreement. It is hoped that to enhance synergies and increase the links between the three projects quarterly online meetings can include stakeholders from all projects.

The British Council will conduct regular Monitoring and Evaluation as well as commission independent evaluations of selected projects that are of strategic importance.

Records of the project including record of activities, contracts, important project document, evaluation reports, spending and supporting documentations related with financial transaction should be kept until seven (7) years after the closure of the project for audit purpose.

13.2 Wider sharing to local stakeholders - online event

To also share progress and key findings with a greater number of local China stakeholders, the final quarterly meeting (December 2022) will also coincide with an <u>online sharing event</u> supported by the British Council. The purpose of this online event is to share initial findings more widely and highlight the potential significance of the gathered research with a wider swathe of local stakeholders. This event will also reaffirm the projects' relevance while building ongoing interest in the project's expected outputs at provincial and national level in China.

14. Data Protection
