South Asia Digital Landscape

803 Mn - Internet users with 42% penetration. South Asia is the second largest region in the world

48% - Mobile's share of internet usage, almost doubling in five years

30% (108 Mn) - of the total Global increase in Internet users on account of India and Bangladesh

450 Mn — Number of active Social Media Users, at only 24% penetration

Twice - as many new internet users in India as in China

53% - Use Ad-blockers in India, the second highest in the world


Bangladesh

163 Mn Population 30% - Youth 8% GDP growth

- £2000 Mn Increase in expenditure on education
- 1,482 Q3 visas- growth of 20.8%
- 1Mn Students looking towards a UG course, 1600 from A level schools
- 58K Students in 2017 at tertiary level studying abroad 2540 are in the UK

Economic growth and a shift in share away from the UK has seen students in other destinations grow since 2013. In addition to traditional competitors, China and Malaysia are major study destinations

Bangladesh TNE


- The new Cross Border Higher Education (CBHE) policy presents fresh opportunities for UK HEIs
- Foreign HEIs can open full campuses, study centers, branch campuses or partner with local institutions
- Local institutions actively seeking partnerships with foreign HEIs.
- There are providers of level 5 qualifications who are looking for potential partnerships for final year top-up.
- Bangladeshi students are receptive towards branch campuses

Sri Lanka

21 Mn Population 23% - Youth 3.5% GDP growth

- £160 Mn Increase in expenditure on education
- 521 Q3 Visas —growth of 7.1%
- 2.2% Government expenditure on University education
- 15 Universities across 623 departments
- 163K Students eligible for UG courses, 20% only admitted–maximum in arts, commerce, bio science, ph. science, technology
- 20K Students in 2017 at tertiary level studying abroad 1225 are in the UK

- A student centred education system, replacing the current examination centred education system
- Establish an aviation university and a nautical university
- All universities to be converted to Smart Learning Universities

- Focus on technical education through expansion of learning opportunities

Sri Lanka – TNE Opportunity

The TNE market continues to grow...

- UK continues to dominate: Over 40 universities and professional bodies offering UK programmes across 70 local institutes with 45000 students pursuing UK qualifications
- Independent Commission on Quality Assurance Oversee QA in state and nonstate sector by UGC


'The local institutions that claim to be affiliated to foreign institutions will also have to maintain the standards of those foreign institutions in Sri Lanka. The commissions will also have powers to revoke the registration of an institution, for failure to maintain proper standards, including the syllabuses and teaching."

Nepal

29 Mn Population 22% - Youth 6.3% GDP growth

- 20K Increase in international students by 2027
- 79% Nepali students study at Tribhuvan University
- Curriculum Development Centre at Tribhuvan University
- 44K Students in 2017 at tertiary level studying abroad 585 are in the UK, Australia (94%). India, US and Japan are the other destinations
- 400K Students are in local curriculum, 3000 in A levels, 60 in IB, 30 active A level Schools including independent centres
- Popular subjects STEM, with math/computer science, physical/life sciences, and engineering.
- 487 Q3 Visas- 114.5% growth

Nepal Opportunities

- Existing links with a handful of local private universities offering UK accredited bachelors and Masters
- Opportunity in mobility with GIR
- TVET is important. 31 technical schools and polytechnics with hundreds of affiliated private TVET providers.










PAK UK Education Gateway

- The overall development goal of the UK-PK Education Gateway is to strengthen and develop human resource capital through improved quality of higher education and skills development institutions in Pakistan.
 - Innovative and collaborative research
 - Higher Education leadership
 - Quality assurance and standard setting
 - Distance learning and new ways of delivery of Higher Education
 - International mobility
 - Transnational education
- Review exercises (Leaderships, teaching and learning, governance, research) travel grants, research grants, mobility grants (long term grants for joined projects faculty and student exchange)

TNE Landscape in Pakistan

- TNE has seen steady growth in Pakistan: 33% growth between 2012 and 2017.
- 4th largest host of TNE students after China, Malaysia and Singapore, over 40,000 students enrolled
- HEC Foreign Collaboration Policy Launched in November 2018 it sets out policy guidelines, criteria, procedures for collaboration with foreign universities including opening of campuses in Pakistan



Partnership and TNE

Two main statutory regulatory bodies for HE partnerships

All India Council for Technical Education

Responsible for approval of Engineering, Technology or Business

University Grants Commission

Responsible for approval of all other programmes


National Higher Education Regulatory Authority (NHERA)

Opportunity for transnational (TNE) partnerships for UK universities

- The total number of students studying via TNE grew by 34% from 2013/14 to 2017/18 though growth plateaued in 2017/18.
- 88% of UK TNE students in India are at Undergraduate level.
- The most common form of TNE delivery is 'Overseas partner organisation' (53%)

While degrees delivered by TNE are allowed, the regulatory conditions mean that qualification recognition remains a challenge

- Foreign institutions operate within a complex regulatory environment with up to six bodies involved in institution /programme approval - AICTE, AIU, UGC, NAAC, NBA and a range of professional councils.
- India also remains a price sensitive market.
- Only way currently is the dual degree programs



Internationalisation of higher education

- Twinning programs have been a source of differentiation for the private Universities but lack of the International qualification in India has restricted the growth
- Inter University Centre for International Education: IUCIE will be set up within selected Indian universities to support internationalisation of higher education in universities.
- Setting up of Indian campus by International Universities is an area that has received a lot of activity within the current government is also part of the new proposed bill on higher education
