Study Visas

 T4 General – Post 16 Education
 T4 Child – Aged 4-17 studying at Independent Schools
 Short term study – 6 months or less (11 months for English Language

It is very difficult to get a UK study visa




Preparing for your visa application

- Tailor your application –Optional additional services are available





Confirmation of Acceptance for Studies (CAS)



You will have to submit the educational documents listed.

Your CAS can only be used for one application



Students need to have the relevant level of English for the course. At degree level or above at a UK HEI

Institution will choose how to assess the level of English Studying below degree level, or at an institution that is not an HEI Will usually need to pass a SELT



You will need to provide evidence to demonstrate that you will be able to support yourself financially during your studies and pay your course fees and living costs



Funds

You must demonstrate you have enough money to pay your first year course fees and living expenses which are:
 Inside London - £1,265 for each month of the course, up to a maximum of 9 months
 Outside London and elsewhere in the UK - £1,015 for each month of the course, up to a maximum of 9 months.

Students can demonstrate they have the money through:

- cash in the bank in the student's name or in the parent(s) or legal guardian(s) name
- an Education Loan in the students name
- official financial or government sponsorship

If you have paid all or some of your course fees to your sponsor before making your application, this can be taken away from the total you need to show



How to demonstrate funds in the bank

You can use:

- Personal bank or building society statements
- Building society pass book
- Letter from the bank or regulated financial institution

The documents should

- Be in the student's or their parent/legal guardian's name
- Show funds have been held for 28 consecutive days
- Be dated within 31 days before the date the visa fee was paid
- Show the account number, financial institutions name and logo



If the funds are held in your parent or legal guardian's name you must show that you are related to them and provide:

- your birth certificate
- your certificate of adoption
- a court document naming your legal guardian(s)

and

• a letter confirming the relationship and that they have given consent to use their funds



How to demonstrate funds using an Education Loan

A Loan Letter:

- from a regulated financial institution
- provided by your national government, state or regional government, a government sponsored student loan company or is part of an academic or educational loans scheme

The documents should

- Be in the student's name
- Be dated no more than 6 months before the date of application
- Show the amount of money available as a loan
- Show the financial institutions name and logo
- Show the money is available to you before you travel to the UK



Official Sponsors

You can receive official financial sponsorship from:

- Her Majesty's Government
- your home government
- the British Council
- any international organisation
- international company
- University
- a UK independent school



You must have a tuberculosis (TB) test if you are coming to the UK for more than 6 months

You must be tested at a clinic approved by the Home Office

Include the certificate with your visa application




You will need an ATAS certificate if you intend to undertake studies in designated science and technical subjects

Check the ATAS guidance on the GOV.UK website



Visa application process



Health Surcharge

- All non-EEA nationals, coming to live in the UK for more than six months are required to pay a 'health surcharge' in order to gain access to the UK's world class National Health Service (NHS)
- The health surcharge is £150 per year for students and is payable at the same time as you pay your visa fees, for the full length of the visa
- You'll still need to pay for certain types of services, such as prescriptions, dental treatment & eye tests
- You should take your biometric residence permit with you when you access healthcare





Most students will be interviewed at the Visa Application Centre

The interview checks you can speak English to the required standard, and that you are a genuine student

Some students may be invited for a secondary interview.

KNOWLEDGE IS GREAT

Interviews may cover:

- The course you have applied for
- Reasons for choosing to study in the UK
- How you will fund your studies
- Your previous studies and future work aspirations
- Your family circumstances



User Paid Services



Priority Service moves your application to the front of the queue We aim to process a decision within 5 working days



The **Keep My Passport When Applying Service** makes it easier for travellers to apply for 2 visas at the same time, by returning an applicant's passport once they have applied for their visa



Premium Lounges offer customers a separate lounge and a faster service to submit documents and biometrics. Customers also receive a courier service and SMS service free of charge



If your visa application is successful

You will be given a vignette in your passport valid for 30 days. You will also be given a decision letter that will outline the full duration of your leave, and where to collect your BRP

You must then collect your BRP no later than 10 days after your arrival in the UK

If there is a problem when you collect it, or gets lost or stolen you should use the online service on GOV.uk







Common reasons student visas are refused

- Not including the correct supporting documents or submitting documents without translations
- Forgetting to include original education certificates
- Not holding funds for a consecutive 28 day period before the date of application, or submitting a balance certificate that shows funds on one day
- Not holding the funds in an account in which you or your parent(s)/legal guardian(s) are named, or not providing evidence of the relationship between you and your parents/guardian
- Failing to disclose full travel or immigration history
- Forgetting to get a TB test done



Will I be able to work while studying in the UK?

All students including those studying at colleges can undertake work placements that are an integral and assessed part of their course of study

Degree level and above

 Students at an HEI can work 20hrs a week in term time and full time in the holidays

Below degree level

 Students at an HEI can work 10hrs a week in term time and full time in the holidays

Private Provider or FE College

 No work is permitted at any level



Can I bring my family with me?

The following students are able to bring their partners and children to the UK:

- Postgraduate students at higher education institutions on courses of 12 months or more
- Government sponsored students on courses lasting longer than 6 months

Each dependant must have a certain amount of money available to them this is in addition to the money you must have to support yourself

They'll also have to pay the healthcare surcharge as part of their application



Options to stay on in the UK after your studies

Tier 2 work visa	 Secure a graduate level job, which pays £20,800 or more to stay for a further 3 years with the option to extend.
Tier 5 internship	 Secure an internship on a Government Authorised Exchange scheme, relating to your course, to stay for a further 12 months
Doctorate Extension Scheme	 Allows completing students to stay for 12 months to gain work experience or set up as an entrepreneur
Tier 1 Graduate Entrepreneur	 If you have a business idea and an endorsement from DIT or your HEI, you could switch onto the Graduate Entrepreneur route

You can apply for a Standard Visitor visa if you want to visit the UK

There are visit visas that last 2, 5 or 10 years. You can stay for a maximum of 6 months on each visit.

Visit Visas can be post-dated by up to three months. Apply in the off peak period to benefit from faster turnaround times and quieter Visa Application Centres

Top Tips

- Start preparing your student visa application well in advance
- Make sure funds in your bank account or that of a parent or legal guardian are held for at least 28 consecutive days.
- Apply for your visa as soon as you receive your CAS.
- Check your course start date before completing your visa application.
- Remember to take all relevant documentation to your appointment
- Don't be nervous about your video interview.
- Be **honest about your immigration history** when completing your application form
- Remember to get a TB test done and **submit the medical certificate**
