English Methodology Course in the UK for English Teachers from TVET institutions in Chile

January – February 2020

Call for Proposals

UK-based, 6 week bespoke English Methodology course for a group of 10 Chilean English teachers from TVET colleges

A British Council stakeholder in Chile is looking for a British Council Accredited language course provider in the UK, to deliver a six-week teacher training course of 30 hours per week in English Language Methodology with a focus on teaching in a TVET setting. The course should also incorporate materials/sessions about teaching students of industry, particularly: technology, IT, renewable energy, agriculture, supply chain management, port management. The course should also include a range of activities such as visits to local centres of industry and excursions on the weekends. The call is open to all institutions who can comply with the requirements set below.

- I. **Duration:** 6 weeks
- II. **Course Dates:** January and February 2020
- III. **Group Description:** A group of 10 Chilean TVET English teachers, with minimum of B1 English level, wishing to improve their English language teaching skills.
- IV. **Accommodation:** Accommodation might be sourced separately for this group. So please simply include the standard weekly prices for homestay and residence for reference.
- V. **Budget:** Your proposal should budget for the following:
 - **Course fees including registration fee** for a 6 week, 30 hour a week English Language Methodology course, with a focus on teaching within a TVET setting to students of Industry. Course can be taught in an open or closed group, or a combination.
 - **Accommodation and any reservation fees** – please include indicatively only.
 - **Course materials**

- **Cultural immersion and/or industry focussed activities** during the stay. These can be weekly cultural activities and/or full day excursions. We would suggest one or two short, evening activities each week and three full day excursions over the weekends, but we are open to suggestions. These are additional components of the course which will enable students to learn more about the UK, its people and culture. The proposals should clearly specify the additional cultural activities and have a learning objective, preferably linked to what students are learning in the classroom. **All incurred fees for the proposed activities should be clearly listed within your proposal.**

Proposal ToRs (Terms of Reference):

- Justification
- General and specific objectives of course
- Teaching methodology and course content;
- Additional components and/or features to the programme (e.g. use of new technologies to support activities and/or classes);
- Materials to be used
- Course certificate
- Proposed breakdown of costs/budget
- Any other additional activities/services as a plus from the language school;
- **Desirable:** Variation of activities in different locations on or off-campus;
- **Contact details of dedicated person assigned to British Council group.**
