Overview of the British Council

We build connections, understanding and trust between people in the UK and other countries through arts and culture, education and the English language. We work in two ways – directly with individuals to transform their lives, and with governments and partners to make a bigger difference for the longer term, creating benefit for millions of people all over the world.

We help young people to gain the skills, confidence and connections they are looking for to realise their potential and to participate in strong and inclusive communities. We support them to learn English, to get a high-quality education and to gain internationally recognised qualifications. Our work in arts and culture stimulates creative expression and exchange and nurtures creative enterprise.

We connect the best of the UK with the world and the best of the world with the UK. These connections lead to an understanding of each other's strengths and of the challenges and values that we share. This builds trust between people in the UK and other nations which endures even when official relations may be strained.

We work on the ground in more than 100 countries. In 2019-20 we connected with 80 million people directly and with 791 million people overall, including online and through our broadcasts and publications.

We are funded by a grant-in-aid from the UK government and with significant additional income from partnership agreements, contracts, teaching and exams.

Founded in 1934, we are a UK charity governed by Royal Charter and a UK public body.

English in Education Systems

The British Council's work in English for Education Systems (EES) aims for transformational change in English language policy and practice. We believe that better teaching and learning of English increases academic and career opportunities and enables people to participate actively in a global society. Our research and innovation with UK and overseas partners provide evidence of 'what works' in English language teaching and learning and contribute to the development of English language teaching and learning worldwide. We support language teaching and learning in a multilingual world, helping to ensure inclusive and equitable quality language education in line with UN Sustainable Development Goal 4.

As of 2021, our EES programmatic framework is thematically organised into three key impact areas:

- ELT in Education,
- English and Empowerment
- English Connects (digital)

Underpinning these priorities is our approach harnessing UK expertise in teacher education, education technologies and inclusive pedagogies and research, insight, and innovation. We seek to document and share learning gained from practical experience. Our role in global English means that advancing thought and positioning the UK as leaders in English language education are at the heart of our mission.

Call for Application (CFA)

UK-China RIA and EMaDA Research and Materials Development Awards

1. Overview of Funding Opportunity

The British Council China is now inviting grant applications from UK organisations for targeted China-UK partnerships in 2 distinct research and materials development award areas. These award areas are intended to support English teacher Continuous Professional Development (CPD) and English language teaching in China through collaborative international partnerships with identified China partners and projects. These are:

- **RIA** Research Innovation Award
- EMaDA English Materials Development Award

UK institutions, ELT and EdTech organisations are now invited to apply to work with preselected China partners under each award category; to help design, develop, pilot, and evaluate required research and resources that will have relevant outputs of national significance in areas of teacher CPD and English language teaching.

Award funding is different for each award category and is outlined below.

1.1 Research awards

The 2021 awards suite is divided into the following 2 areas:

RIA

The China Research Innovation Award (RIA) is an annual research award that:

 promotes <u>innovative research partnerships</u> which can support and directly contribute to national education priorities creating impact at provincial and national level in identified areas of ELT within Chinese formal basic education through implementation of targeted, nationally relevant research.

Within the China Official Development Assistance (ODA) context the RIA award seeks to connect prominent local China partners with UK ELT and research expertise in order to facilitate, support and/or contribute to research that aligns with identified national policy and/or

current or emerging national priorities. Where possible identified research areas will have crosscutting relevance to the East Asia region.

EMaDA

The China English Materials Development Award (EMaDA) is an annual award that:

• promotes UK - China collaborative <u>technical research partnerships</u> which can support national education priorities and create <u>impact at a provincial or national level</u> within identified areas of ELT in Chinese formal basic education through the implementation of targeted, nationally relevant research <u>and</u> subsequent creation of contextualised materials and/or content that supports and sustains a positive impact in English teacher CPD and the quality of English teaching, learning and assessment.

Within the China Official Development Assistance (ODA) context, the award seeks to identify prominent local partners and areas of need in alignment with China national policies and priorities, and within identified research categories, and connect these partners with UK expertise. The EMaDA award seeks to generate both insightful and nationally relevant research while also providing related context-led material and/or content creation that can promote sustained and meaningful impact.

Created materials cannot be used for any future commercial purposes.

Note: A full list of outcomes for each award can be found in Appendix 7

1.2 Research Areas

Local China partners, at national and provincial level, will first be identified by the British Council. UK organisations will not have to source partnership for project activities and, instead, will be invited to apply to collaborate with selected Chinese partners to meet their contextual needs under the relevant grant funded award.

Research programmes associated with partner needs will broadly fall under at least one of 5 key research areas. Further detail and contextual information can be found in Appendix 7.

- Supporting English teaching in rural areas
- EdTech and digital solutions for English teacher CPD
- Assessment reform and English teacher's assessment literacy
- New curriculum and material development
- Broader English teacher CPD and policy

Note: In line with ODA grant funding requirements all applications must explicitly include consideration of gender, inclusion and/or girls education. See *section 11* for more details.

2. Eligibility

- The British Council welcomes applications from UK ELT and EdTech organisations or institutions with relevant qualifications, expertise and experience required to meet identified partner requirements.
- We are inviting applications for innovative responses to this open call. Applications for partnerships are open to UK organisations only. This must include at least one partner within the UK Applicants living in the UK at the time of application and for the duration of this project.
- Applicants with in kind or matched support are welcome, although this is not essential. Match funding cannot be provided through other British Council funded programmes.
- Applications should be jointly submitted and signed by all named collaborators, with one principal applicant e.g. a lead UK partner organisation, who will be contracted and responsible for leading communications and disseminating the grant to all collaborators.
- Organisations and/or informal collectives/networks are eligible to apply but should have demonstrable experience of managing similar projects and grants.
- Applicants must be able to demonstrate how their involvement will provide clear benefit to China and the proposed project. This should be reflected through proposed project planning (including budget allocation), delivery and dissemination and includes demonstrating how the local partners or their audiences may benefit. Mutuality must be a central component to our international collaboration.
- We expect applications to embed principles of equality, diversity and inclusion through their core proposal and idea (including, potentially, costs relating to captioning videos or translating content where applicable).

- We are interested in new, original ideas and approaches in response to this brief. Existing research, projects and programmes will be ineligible. Exceptions apply for existing ideas, where applicable, which have reached a pilot or prototyping phase but have not been realised publicly or implemented.
- Applicants will be expected to plan, design, and realise their project between January 2022 • and March 2023 (RIA; EMaDA) Main activities can take place any time during the year, although we anticipate that you will respect the annual academic calendar (and holiday breaks) in China.
- Successful applicants will own the copyright of any work created (unless otherwise stated¹) but must grant the British Council, the local China partner and the China Ministry of Education, free and unequivocal use of any arising outputs, which may include promotion of works through our digital channels, supporting other projects or exhibiting works in the future. For the avoidance of doubt, this license will not include use of any work for commercial purposes.
- Successful applicants will be required to keep in regular communication with the British • Council, offering project updates and share their project monitoring and evaluation progress and final reports for review and publication.
- Depending on the nature of the project, UK partners may need to show evidence of relevant • indemnity cover and related insurance provisions for research activities. The details and nature of insurance required should be confirmed at the time of application.

3. Total Funding and Project Duration

The funding for each award is divided into the following amounts:

- **RIA:** Up to 20,000GBP per award
- EMaDA: Up to 30,000GBP per award

The number and type of award available is dictated by the number of identified local partners and their needs within local contexts. See section 1.3 above.

RIA and EMaDA awards projects in receipt of funding will be expected to start in January 2022 and can run for a maximum of 15 months (until March 2023). The funding is for the whole project duration and not per annum. Terms and Conditions of this grant is set out in Appendix 4: Grant Agreement.

4. Eligible Costs

The budget requested in your application should cover only costs that are essential, appropriate, and relevant to the collaboration ensuring value for money. The application should specify any cost share through direct and indirect institutional contributions.

Application process and selection

Upon receipt of applications, and after confirming all necessary criteria are met and necessary documents have been received, up to <u>3 applications² will be shortlisted</u> and these submissions will be shared with the relevant Chinese partner for further review.

The British Council will then support a *negotiation and confirmation stage* between the Chinese partner and shortlisted UK applicants to confirm any outstanding details, before final selection.

After conclusion of discussions, a final decision will be made on successful applicants for each award primarily by the Chinese partner and based on appended scoring (See Appendix 6).

Support and clarification will be provided by the British Council during the selection process to ensure assessment and scoring criteria are adhered to.

6. Assessment Criteria

All application will be assessed against the following criteria:

- Potential to deliver innovation and/or teacher CPD impacts and outcomes (40 points)
- Alignment with grant strategic objectives (30 points)
- Principal Applicant and its partner's capacity to deliver on time and within budget (30 points)

8. Payment of the Grant

After the results are announced, the British Council will sign Grant Agreements with the successful principal applicants. Unless stated otherwise, funding from British Council will be administered within 60 days of the signature of the Grant Agreement and all funded applicants must submit a declaration confirming they have received the funds.

The grant recipient institution that signs the agreement will then be responsible for the management of the grant (including financial reporting). The Principal Applicant is responsible to communicate and agree with their identified research team on the project's grant management and disbursement. The final terms will be communicated to successful applicants.

The British Council reserve the rights to recover full payment if the final report and supporting documents are not satisfactory, or the activities have not been delivered as planned.

In cases where the projects have spent less than the funding awarded, the underspend cannot be used for further activity unless agreed in advance by the British Council.

9. Implementation

All funded projects must be implemented in accordance with the submitted application, Grant Agreement, and other formal / written communication by the British Council. Any changes to proposed project activities must be approved by the British Council before going ahead.

10. Digital Platform

At this stage, given current travel constraints due to covid-19, it is envisioned that the majority of partnership activities will be conducted remotely, unless there are already teams or personnel in country. Should the situation improve, there may be opportunities for face-to-face operations.

The British Council's Global Information Security Policy recommends using Microsoft Teams as the principal means of virtual activities. Principal Applicants, who want to use other online tools or online platforms, must follow British Council's safeguarding and security protocols. 11. Diversity and Gender Statement

Diversity statement

The British Council is committed to equal opportunities and diversity in all our activities. This includes avoidance of bias due to gender, disability, racial or ethnic origin, sexual orientation, or religious belief. Applicants are therefore encouraged to include participation by participants from under-represented groups in the teams implementing their proposed research. Applicants may apply for funding to cover extra costs for such participate, or for childcare. Gender statement

To comply with the International Development (Gender Equality) Act 2014, applications must outline how they have taken meaningful yet proportionate consideration as to how the project will contribute to reducing gender inequalities in the Gender Equality Statement section of the application form. Applicants are required to consider the impact their project will have on

gender. We aim for projects to be gender sensitive. This will be an assessment criterion for this call. This should be about the project specifically – the outputs and outcomes; the make-up of the project team; participants, stakeholders and beneficiaries of the project; and the processes followed throughout the partnership programme. It should not be a re-statement of your Institution's policy, you may refer to the policy, but should show how the policy will be implemented in terms of the project. The Gender Statement must address the below criteria, with an understanding that, depending on the nature of the application/proposal, not all questions will be applicable. If a question is not applicable, you will need to articulate the reasons why.

- Have measures been put in place to analyse the needs and to ensure equal and meaningful opportunities for people of different genders to be involved throughout the project? This includes the development of the project, the participants of the research and innovation, and the beneficiaries of the project.
- The expected impact of the project (benefits and losses) on people of different genders, both throughout the project and beyond.
- The impact on the relations between people of different genders and people of the same gender. For example, changing roles and responsibilities in households, society, economy, politics, power, etc.
- How will any risks and unintended negative consequences on gender equality be avoided or mitigated against, and monitored?

British Council reserve the right to reject the application if no consideration has been given to gender equality or if any proposal is assessed to result in a negative impact for gender equality.

12. Safeguarding

13. Project Reporting, Monitoring and Evaluation

During the duration of research, the Principal Applicant is responsible to submit Quarterly Report and Annual Report to the British Council³. This report shall consist narrative and financial information that tracks progress against milestones / plan. In addition to this, the Principal Applicant will be required to submit a final narrative and financial report within 30 days

upon completion of the project. Project report template will be provided prior to Inception Meeting.

The British Council will conduct regular Monitoring and Evaluation as well as commission independent evaluations of selected projects that are of strategic importance.

Record of project including record of activities, contracts, important project document, evaluation reports, spending and supporting documentations related with financial transaction should be kept until seven (7) years after the closure of the project for audit purpose.

14. Data Protection

The British Council will use the information that you provide for the purposes of processing your application, making any awards, monitoring and review of any grants. The legal basis for processing your information is agreement with our terms and conditions of application (contract).

We may share all application data with the local China partner in order to assist with management of the application process.

The British Council comply with the General Data Protection Regulations 2016/679 (EU) GDPR). We process and handle personal information according to these regulations. The personal information that you provide on this form will only be used for the processing of your application. The information will be viewed by British Council and those who are part of the decision-making process. Your information will not be used/shared beyond the partners listed above for any other purpose without your specific consent. British Council reserve the right to publish and share anonymized aggregated information with stakeholders.

Organisation details, where collected, are used for monitoring and evaluation and statistical purposes. Gender information and country of origin, where collected, is used solely for statistical purposes. If we need to contact you, we will do so using the contact details you have provided.

Under UK Data Protection law, you have the right to ask for a copy of the information we hold on you, and the right to ask us to correct any inaccuracies in that information. 15. Applicant Screening

In order to comply with UK government legislation, the British Council may at any point during the application process, carry out searches of relevant third-party screening databases to ensure that neither the applicant nor any of the applicant's employees, partners, directors, shareholders is listed:

- as an individual or entity with whom national or supranational bodies have decreed organisations should not have financial dealings;
- as being wanted by Interpol or any national law enforcement body in connection with crime;

- as being subject to regulatory action by a national or international enforcement body;
- as being subject to export, trade or procurement controls or (in the case of an individual) as being disqualified from being a company director; and/or
- as being a heightened risk individual or organisation, or (in the case of an individual) a politically exposed person.
- If the applicant or any other party is listed in a Screening Database for any of the reasons set out above, the British Council will assess the applicant as ineligible to apply for this grant call.

The applicant must provide the British Council with all information reasonably requested by the British Council to complete the screening searches.
