### Call for UK institutions to join promotion for China Education Expo 2015

The British Council China is delighted to invite UK institutions to participate in promotional activities surrounding the China Education Expo 2015, which is organised by the China Education Association for International Exchange and will run from 24 October to 1 November 2015 in Beijing, Chengdu, Guangzhou and Shanghai. This is a great opportunity for UK institutions to build awareness of their educational offering among prospective students, agents and other industry representatives in China, and to increase the overall impact of the UK pavilion's promotion.

Content may include a brief introduction of your institution and facilities; detailed information on your courses; profiles of academic staff, students and alumni; and other general information about studying at your institution.

- Access and foundation level
- Applied and pure sciences
- Architecture, building and planning
- Business and administrative studies
- Computer and mathematical sciences
- Creative arts and design

- Humanities
- Law and legal studies
- Social studies and communications
- Tourism, travel and hospitality

The 2015 Education UK Exhibition Guide will be in Chinese language.\* Each participating institution is invited to produce an A5 (148mm x 210mm) advertisement with the institution's own branding. This can either be provided as a ready-to-print artwork (preferred), or as text files and photos along with the institution's branding guidelines for the British Council's own graphic designers to finalise. It is suggested that each page should contain the institution's logo and at least one photo to make the page visually attractive.

#### **Terms and conditions**

#### 1. Accredited institutions only

All participating institutions must be accredited by a recognised UK authority.

#### 2. Payment schedule

Event participants will be invoiced by the British Council. Payment must be received within 30 days of the invoice date.

#### 3. Cancellation

A participating institution may withdraw from the 2015 Education UK Exhibition Guide and/or 2015/16 Scholarship Booklet by giving advance written notice. If an institution cancels at least 21 days prior to **16 October 2015**, it will not be required to pay the British Council any fees in connection with the cancelled services and any fees already paid in respect of such cancelled services will be refunded by the British Council. If an institution cancels less than 21 days prior to **16 October 2015**, it will be required to pay the British Council a percentage of the charges for such cancelled services as set out below:
