

Call for UK Speakers: SEA-TVET Harmonisation and Mobility

British Council is inviting expressions of interest from UK experts in further education to speak at a country-level workshop in Thailand on "SEA-TVET Harmonisation and Mobility".

This project is in partnership with the Office of the Vocational Education Commission (OVEC), Thai Ministry of Education and the Secretariat of the Southeast Asia Ministers of Education Organization (SEAMEO).

Background

Within the context of ASEAN integration, and understanding the expected increase in mobility of skilled workers in the region and the need to improve the quality of technical vocational education and training (TVET) in South East Asia, SEAMEO - with funding from OVEC - organised the first High Officials' Meeting (HOM) on SEA-TVET. This was held under the theme: "Working Together towards Harmonisation and Internationalisation of TVET in South East Asia". The event took place between 24th and 26th August 2015 in Chiang Mai, Thailand. As a result, the "Chiang Mai Joint Statement on Harmonisation and Internationalisation of TVET in Southeast Asia", which included four priority industry areas, was officially announced as the key driver of regional policy direction in this area.

Following on from the HOM on SEA-TVET, a workshop on "Internationalisation and Harmonisation of TVET in Southeast Asia" was hosted by the Ministry of Education and Culture (Republic of Indonesia) and the German Academic Exchange Service (DAAD) from 10th to 12th September 2015 in Solo, Indonesia.

Building on the outcomes of these two events, seven country-level workshops on "SEA-TVET Harmonisation and Mobility" are planned to be conducted over one to two days in each of the seven countries. The aims are to collate the results from the previous TVET regional meetings and develop partnership and commitment among participants.

The second country-level workshop on "SEA-TVET Harmonisation and Mobility" in Thailand.

As a part of the country-level workshop series in seven countries, the second country-level workshop on will be hosted in Thailand by OVEC. The workshop is tentatively scheduled for three days, between 26th and 28th November 2015, in Bangkok.

International collaboration	40%
Industry engagement	30%

Evaluation will be fair and transparent.
