



Q: How likely are you to cancel or delay your plans to study overseas?




Q: How likely are you to cancel or delay your plans to study overseas?

China new enrolments in the UK




- SARS was a small and highly localized crisis by comparison.
- China was at a much lower state of economic development.
- But extent to which SARS disrupted the rise of outbound study is nonetheless notable.

Jobs, jobs, jobs

Expect a much greater focus on employability for the next 5-10 years

Previous experience suggests that it will take at least 5 to 10 years for employment rates to recover





China Survey


Q: If you are unable to start your overseas course on campus in autumn, which of the following options would be most attractive to you? (UK offer holders)

Transnational education

- Near-term is complicated by limited ability to accommodate a short-term surge in demand.
- Underlying problems of TNE sustainability remain unresolved.
- Hybrid TNE/online models could be the way forward, but only if regulators concede.

Consolidation

The core of international ed will reemerge, but peripheral services will never be the same. **Consolidation of peripheral IHE industries**



- The peripheral industries around IHE will see massive consolidation.
- There will be a 'missing middle' between small firms and the last giants standing.
- Post-Covid universities will outsource more market-facing work

Air travel

Complicated in the short term, more expensive in the medium term

Air travel: The backbone of mobility

- Two-thirds of the world's 26,000 passenger aircraft are grounded.
- Near-term travel will be complicated by pre-flight health checks, lack of available routes/seats and travel restrictions put in place by governments.



Air travel: The backbone of mobility



- 25 million air industry jobs at risk.
- Carriers face a US\$314 billion shortfall in ticket sales this year.
- Half face bankruptcy in two to three months without government help.
- Passenger air travel is a high-volume, low-margin business. Consolidation and reduction in volume will inevitably lead to higher prices.
- Minimum 2-3 years for industry recovery

Conclusions

The road back to 'normal'

Conclusions

- Impacts on 2020/2021 enrolments could still range from moderate to severe. Either way, the recovery will be slower than the decline.
- Employability will gain even greater importance over the coming years.
- Online will boom as a stop-gap, but longer-term potential remains limited. Unresolved sustainability issues mean that TNE is poised for a shakeup.
- IHE's peripheral industries will emerge in a very different form.
- Rising air travel costs create medium-term risks for international mobility.
