### 15:45-16:45 Setting the policy scene for TNE in Romania: panel discussion

**Mr. Bogdan Cristescu**, State Secretary, Ministry of Education, will present a national perspective on the internationalisation of HE in Romania. The new Higher Education legislation includes dedicated provisions for joint, double and multiple degree programmes and microcredentials.

The quality oversight of HE provision lies with ARACIS. This is an opportunity to hear from **Prof. Teodor Ioan Trașcă**, Vice-president of the Romanian Agency for Quality Assurance in Higher Education (ARACIS) on the proposed steps to safeguard TNE quality.

**Mr. Josh Fleming** from the Office for Students (OfS) will detail the regulatory and oversight arrangements that ensure English HEIs deliver a high-quality educational experience and excellent outcomes for students, wherever their HE course is delivered.

**Mr. Piers Wall** from the UK's Quality Assurance Agency will draw on the QAA's experience in quality assessment of TNE over the past decades and their work with quality bodies internationally.

#### 09:15-10.15 Panel discussion

This session will start with an overview of the work of the **National Council of Rectors**, from **Prof. Costel Negricea**, Vice-president, a sector body representing 74 Romanian universities.

**Universities UK**, a sister organisation to the National Council of Rectors, is the collective voice of 142 universities in England, Scotland, Wales, and Northern Ireland, which was founded in 1918. **Ms. Franziska EnichImayr** from UUK, will showcase areas where successful campaigning and lobbying have protected the core work of UK universities, such as the association of the UK to Horizon Europe, international students and graduates, and global engagement activities, including TNE.

**Mr. Fabrizio Trifiro** from **Ecctis and Ms. Gianina Chirazi** from the **National Centre for Recognition and Equivalence of Diplomas (CNRED)** will detail the recognition of international degrees and qualifications in Romania, with a special focus on TNE degrees.
