





Travel Grant – Open Call Guidelines

Project on Strengthening Leadership with Gender Equity, Diversity and Inclusivity (GEDI) in Higher Education Institutions in South East Asia

Call opens: 4 October 2024 Call closes: 10 October 2024

1. Background

1.1 As part of SEAMEO RIHED's efforts towards the Common Space in South East Asian higher education, SEAMEO RIHED and the British Council have co-led a regional project titled "Strengthening Leadership with Gender Equity, Diversity, and Inclusivity (GEDI) in Higher Education Institutions in South East Asia" (Phase 1: 2022-2023 and Phase 2: 2024-2025). This initiative forms part of the British Council's Going Global Partnerships, fostering equitable access and inclusion within faculty and leadership roles across higher education institutions in South East Asia. The project has been a profound learning process, where collective intelligence has contributed significantly to policy dialogues and influenced policy changes in South East Asian countries.

1.2 Phase I of the project, which concluded in November 2023, was developed in consultation with the Institute of Development Studies (IDS) and brought together leaders from both South East Asia and the UK. The outcomes included a comprehensive white paper, which was presented to South East Asia's education ministries. Engaging 35 universities from South East Asia and 5 from the UK, Phase I focused on leadership development, the exchange of ideas, and practical approaches to embedding GEDI in higher education, in alignment with SDGs 4, 5, and 17. The extensive networking fostered through this phase established valuable relationships and built trust among global academics. This phase also highlighted the importance of understanding the unique challenges and opportunities within the South East Asian context, reinforcing the spirit of collective learning. It highlighted the pivotal role of collaboration in shaping policies that advance the Common Space for Higher Education in South East Asia, which has been at the forefront of SEAMEO RIHED and the British Council's joint efforts. 1.3 Building on the accomplishments and insights gained from Phase I, Phase II, which began in July 2024, seeks to further enhance the dialogue and deepen the understanding of GEDI issues among higher education leaders and policymakers in South East Asia. A series of activities will

be implemented in Phase II, including in-person and online Transformative Leadership Workshops, the UK-SEA Gender Challenge Grant, and key stakeholder fora. The 35 South East Asian universities that participated in Phase I will continue to engage in this phase, and the call for UK participants is now open.

1.4 Successful UK participants will join the Phase II project and will be funded to attend the first face-to-face Transformative Leadership Workshop in Bangkok on 24-25 October 2024 through the Travel Grant. Attending this workshop will provide participants with the unique opportunity to engage directly with high-level policymakers and university leaders from South East Asia. This engagement is particularly valuable for those interested in Transnational Education (TNE) or the broader internationalisation agenda, as it opens doors for deeper collaborations and partnerships. Furthermore, participants will gain insights into the importance of collaborating with South East Asia, reinforcing the spirit of collective learning between the UK and South East Asia. This collective intelligence continues to play a crucial role in influencing policy dialogue and shaping the future of higher education in the region.

2. Objectives and Outcomes

2.1 The Travel Grant has been designed to facilitate collaboration between UK and South East Asian institutions by enabling UK academics to actively participate in Phase II of the GEDI project.

The objective of the Travel Grant include:

- Engage in the learning process by actively exchanging knowledge, insights and good practices with the participating SEA institutions to drive change and to implement gender-responsive projects and programmes.
- Enhance the knowledge, understanding, and interest of UK stakeholders by learning the good practices in the context of South East Asia's higher education common space, particularly in relation to Gender Equity, Diversity, and Inclusivity (GEDI).
- Foster the development of new connections and enhance existing long-term collaborations between UK and South East Asian institutions.
- Generate sustainable partnerships that contribute to lasting change within higher education systems in both regions.

2.2 Up to 6 UK academics will be selected to receive the Travel Grant, which will cover travel expenses to attend the Transformative Leadership Workshop in Bangkok, Thailand, scheduled for 24-25 October 2024. Recipients are expected to participate fully in all Phase II activities, including the workshop in Bangkok, and contribute to ongoing efforts to embed gender-sensitive leadership and practices in higher education.

2.3 The Travel Grant is open to an individual with experience leading a project, research or transformation on gender issues within higher education management, teaching and policy formation. Successful applicants will have a strong interest in sharing and developing knowledge

in this field, establishing new connections, and engaging with the South East Asia region. We seek participants who are passionate about raising awareness, exploring innovative solutions, and driving change at the institutional level. Ideal candidates will also be committed to creating a lasting impact with the insights and experience gained through the project.

3. The Opportunity: Travel Grant

3.1 The participant will join the face-to-face Transformative Leadership Workshop in Bangkok between 24-25 October 2024, and will participate in a series of workshop activities with 35 university leaders and 11 government representatives from 11 countries of South East Asia in the project. The participant will have networking opportunity with South East Asia participants and potential research collaboration on GEDI with like-minded people from the region. The participant will be eligible to apply for UK-SEA Gender Challenge grant with the South East Asia participants which will be announced during the Workshop.

Project Dates and Preparation

The participant must commit to the following activities as part of Phase II of the project:

- Pre-travel preparation 1: develop a 5–10 minutes collaboration pitch highlighting your work on GEDI initiatives within your university. The participant will need to present it at the Workshop.
- Pre-travel preparation 2: A Concept Note to explore possible GEDI research collaboration with South East Asian Higher Education leaders
- In person Transformative Leadership Workshop, 24-25 October 2024, Bangkok
- Online follow up sessions (Jan 2025, March 2025, April 2025, May 2025, June 2025)
- Online Final Stakeholder Forum, 20-21 August 2025

The participants are expected to:

- Be prepared with a 5-10 minute presentation that showcases their work on GEDI initiatives within their university, highlighting key achievements and opportunities for collaboration.
- Be prepared with a Concept Note to explore possible GEDI research collaboration with South East Asian Higher Education leaders.
- Be able to travel to Bangkok and attend the 2-day workshop between 24-25 October 2024.
- Engage actively in all Phase II activities, including workshops, networking sessions, and collaborative projects, and dedicate time to preparation and research, including online briefing/preparation sessions with SEAMEO RIHED and the British Council.
- Participate in the documentation, communication, wrap-around activities, and evaluation of the programme.
- Share knowledge and good practices related to GEDI gained through the workshops, within their institutions and the broader academic community.

- Maximise opportunities for joint research or projects with South East Asian partners, with the potential to apply for UK-SEA Gender Challenge Grants (themes TBA) to support these initiatives.
- Submit a project report at the end of the project.

4. Who can apply?

- 4.1 We are looking for up to 6 UK academics who;
 - are committed and interested to work in GEDI in higher education with counterparts in South East Asia.
 - have substantial professional experience and work in the area of GEDI in higher education.
 - are willing to collaborate with others.
 - have strong network in the UK that can be activated to amplify the awareness and impact of the overall programme's activities and objectives.

The travel grant is open to people of all genders.

5. Eligibility criteria

5.1 Applicants must be UK academics who:

- are based/living inside of the United Kingdom unless temporarily living but retaining a home address in the United Kingdom and defined by His Majesty's Revenue & Customs as 'resident the in the UK' for tax.
- are able to travel to Bangkok and join the workshop on 24-25 October 2024 and participate in all of Phase II activities.
- Share the British Council and SEAMEO RIHED's commitment to Equality, Diversity, and Inclusion (EDI) and will embed best EDI practices into your activity. (Read the British Council's EDI Strategy and Policy <u>here</u>; and SEAMEO RIHED's Overview of GEDI in SEA higher education <u>here</u>.
- UK organisation must be from one of the following:
 - Higher Education provider with <u>degree awarding powers</u>.
 - England Check the 'awarding degrees' drop down section on the specific provider's entry on the <u>OFS register.</u> The OFS register lists all institutions which offer UK degrees, not all of which have degree awarding powers.

- Any public or private organisations with a role in the Technical and Vocational Education Training (TVET)/Further Education (FE) system
- Having experiences on GEDI related research/studies/projects is a plus.

6. Payment and spending

6.1 Following announcement of the results, SEAMEO RIHED will sign an Agreement with the participant's UK institution. Expenses incurred by the participant or the UK institution prior to the start date or beyond the end date of the signed Agreement, including any costs incurred in the production of the proposal, cannot be charged to SEAMEO RIHED or the British Council.

Logistics will be booked by SEAMEO RIHED.

The participant will receive:

- Economy flights
- Hotel accommodation
- Selected working lunches and tea breaks
- Local transportation cost

7. Selection Criteria

7.1 Eligible, reviewed applications will be jointly assessed by SEAMEO RIHED and the British Council. Proposals will be assessed by two reviewers against the criteria below. The Review Panel will give each application a final score from 0 to 100 and rank them. Those receiving a final score from the Panel meeting of less than 50 will be considered not fundable. However, please note that achieving an average score equal to or above the threshold does not mean that the proposal will be funded.

The final selection decision will be made by SEAMEO RIHED and the British Council.

¹ What is disability?

^{&#}x27;Impairments' can be sensory (e.g. hearing), recurring (e.g. ME), organ-specific (e.g. asthma), mental health conditions (e.g. anxiety and phobias) or mental illnesses e.g. depression. Drug and alcohol addictions are not regarded as impairments.

^{&#}x27;Substantial adverse effect' would take into account how long the person with the impairment takes to carry out a task compared to a person without it.

^{&#}x27;Long-term effects' are those that have lasted at least 12 months; or are likely to last at least 12 months; or are likely to last for the rest of the life of the person affected. Long-term effects also include those that are likely to recur.

^{&#}x27;Day to day activities' are things people do on a regular or daily basis. Examples include shopping, reading, writing and work-related activities such as interacting with colleagues, using a computer, preparing written documents and keeping to a timetable.
