- qualify for a certificate that you and your organisation can benefit from since it is well-recognised by all UK institutions including British Council accredited language schools, boarding schools, colleges, universities, UCAS and also for prospective students seeking advice for study opportunities in the UK




The aim of the training programme is to develop knowledge of the following:

- the UK education and training system; courses and qualifications at each level
- the attractions for students who are considering studying and living in the UK
- · quality assurance mechanisms and how they operate
- student lifestyle issues living costs, travel and accommodation
- course fees and scholarships
- welfare and support provided for international students in the UK
- UK application procedures and standard entry requirements; visa and immigration regulations

Benefits of taking the course

Agents find the training immensely valuable, not just for the information and knowledge they gain but also for the contacts and networks they develop during the training.

Please note that the certificate is awarded to the candidate undertaking the course, and NOT the agency which the candidate works for.



If you successfully pass all components of the course, you will be listed on the Global Advisors List (GAL) website at www.bcagent.info/gal. The qualification is valid for a period of two years.



Gaining the certificate





The final assessment is a written paper which is taken under examination conditions at British Council or a hotel in Bangkok, which accounts for 90% of the final mark. The completion of a 'professional development record' forms the further 10% of the final mark

The paper comprises of scenario based questions and is marked as follows:

- pass with distinction: 75% and above
- pass: 50% and above
- deferred certificate: 49% or less.

Course fee

The cost of training is THB 9,900 (excluding VAT).
