A visa seminar for local agents was organised by the British Council in Bangladesh on 5 May 2015. . Officials from the UK Visas & Immigration (UKVI) of British High Commission (BHC) Bangladesh presented to local agents and responded to different queries on recent visa issues and highlighted the UK Tier 4 visa policies. The officials from the UKVI of British High Commission also appreciated the constructive feedback from local agents.







