

A controversy recently broke out on social media over the New York Times, CNN and the BBC featuring photos of Turkey in their coverage of the COVID-19 pandemic. The outlets published photographs of wellknown Turkish landmarks in a manner that seemed to portray Turkey as a hotspot of the outbreak. The incident left people in Turkey scratching their heads because at the time, we only had one confirmed case of the virus and had begun implementing restrictions to stem its spread.

Turkey is worth talking about, however, because our response to the pandemic is relevant beyond our borders, even more so than some others. As the bridge between Europe and Asia - the home of one of the largest, most highly-trafficked airports in the world, and a state bordering one of the original hot zones, Iran - the way in which we manage the COVID-19 outbreak matters to the global response.

# **Education sector's response**

25 million students are affected by school closures

- schools until 30 April,
- universities until 15 May
- Distant education (online and TV) is introduced for primary and secondary education
- Centralised university examinations are posponed
- Over 100 universities started delivering education online in varying degrees.
- HE students are allowed to suspend their studies for spring term
- No Erasmus in Autumn 2020/21







## **COVID-19 Timeline in Kazakhstan**

16 Mar State of emergency announced 19 Mar **Lockdown** in Almaty and Nur-Sultan 30 Mar - 5 Apr All **businesses** are told **closed** – subsequently extended till end of April 6 Apr Distance learning: **Televised lessons** broadcast on a few national TV channels

16 Mar University/TVET students start online learning 19 – 30 Mar International flights to Almaty and Nur-Sultan are stopped

2 Apr **Online** lessons for schools students piloted

# How the virus outbreak impacts the Education Sector in Kazakhstan



#### Challenges:

- •Not all education facilities and families are ready to move to e-learning
- Difficulties holding assessments and exams
- •Online teaching expertise need enhancements
- •Students under the lockdown pressures are demotivated
- "Double crisis" fall in oil prices and Tenge devaluation
- •With most businesses closed, those who were planning to go for studies abroad in 2020 are uncertain

#### **Opportunities:**

- Education sector is able to pilot, test and improve e-learning
- Students are becoming more independent in studies
- Huge leap in acquiring new knowledge and skills through online courses
- Students have time to think and learn what skills and knowledge they want to have, which is a good thing for their choice of specialism



## **State response to Covid-19**



- March 24 April 20, 2020: full lockdown of Tashkent and all regional centers
- April 18, 2020: restrictive measures extended until May 10.
- Tashkent the most disciplined city during quarantine in CIS according to Yandex with almost 100%

**Stats:** 1,565 cases of coronavirus are affected, 238 patients recovered, and 5 deaths were recorded

## **Education sector's response**

- Online and TV education is introduced for primary and secondary education
- Call to individuals and organisations with online education experience to support ministry
- All Universities moved to online education
- MHSSE announced extension of distance learning and end the current academic year until July 1
- At the same time, teaching staff is transferred to the remote work mode
- Bachelor graduates will take state exams in the form of online tests. To this end, university leaders were instructed to carry out organizational and methodological work
- State certification for graduate masters will also be organized in the form of online presentations

## **Main challenges and opportunities**

## Challenges:

- Not all education institutions and students are ready to move to elearning – no experience and expertise
- No online resources and course content/methodology
- Difficulties holding assessments and exams
- Lockdown pressures
- Economic pressures: budget cuts, savings, scholarships

## **Opportunities for UK:**

- Education sector is able to pilot, test and improve e-learning
- Opportunity to form TNE collaborations with local HEIs
- Great need for online learning and assessment solutions
- Digital marketing to students as they are becoming more independent
- Webinars on Study UK and other available study programmes
- Work with education agents and agencies

## **SOME FACTS AND FIGURES**

## Numbers of Uzbek students entering HE

- In 2019, 1 066 922 pupil applied for 110,000 places available in HE sector
- Almost 92% of school leavers expressed their intention to enter a university in 2019
- 56.8% intend to apply at the place of residence 43% want to apply higher education institutes located in Tashkent.
- In aggregate, almost 80% in case of non-enrolment intend to use other opportunities of getting higher education – 7.6% will go to the extramural studies, 15.4% will try to enrol in foreign universities and 56.3% will prepare to enrol next year.
- Highest competition to enter local university was at National University of Uzbekistan

   29.47 pupil to 1 place. In average for Uzbekistan as a whole 10.28 people applied
   for 1 place available.

#### Number of places available for Uzbek students in Uzbek HEIs

- Bachelor 80,430
- Distance HE Bachelor 19,985
- Evening Shift HE Bachelor 1,985
- Masters 7,695

#### Number of Uzbek students going abroad for HE

- It is estimated around 80K students went abroad to study in 2020
- Most to Russia, China, Korea and Baltic states
- UK: HESA stats in 2018 200, 2019 230

#### Info we have on size of the market of those considering taking a TNE delivered course

 In 2019 survey showed that 15.4 % of pupil wanted to apply for foreign HEs in Uzbekistan. That is 164,306 pupils

# **SOME FACTS AND FIGURES**

#### **TNE relations with Uzbek partners**

- Since 2017, 9 new international universities have been set up with TNE providers from Russia, US and South Korea
- New "El Yurt Umidi" Foundation offers over 1,000 scholarships annually: in 2018 112 scholarship winners went to the UK, in 2019 90 scholarships (tbc)
- The total number of HEIs has been increased from 77 in 2016 to 109 in 2019.
- 16 new joint programmes have been introduced in cooperation with prestigious overseas universities.
- Two UK providers started delivering their foundation programmes in Uzbekistan since 2017
- We had visits by: University of Bath, Coventry University, Edinburgh College

#### Partnering with UK orgs to deliver TNE course

• National Higher Education Reform Decree requires all local universities to teach at least one programme in English by 2020. This means almost every University is looking for partnership opportunity.
